The sealed & signed quotation shall reach to the office of Executive Engineer, Lower Yamuna Division, CWC, Agra on or before 08.02.2024 upto 11:00 A.M. and will be opened on the same day i.e. 08.02.2024 at 12:00 P.M. in the presence of undersigned and bidders or their representative who may likely to be present at the time of opening of quotations.

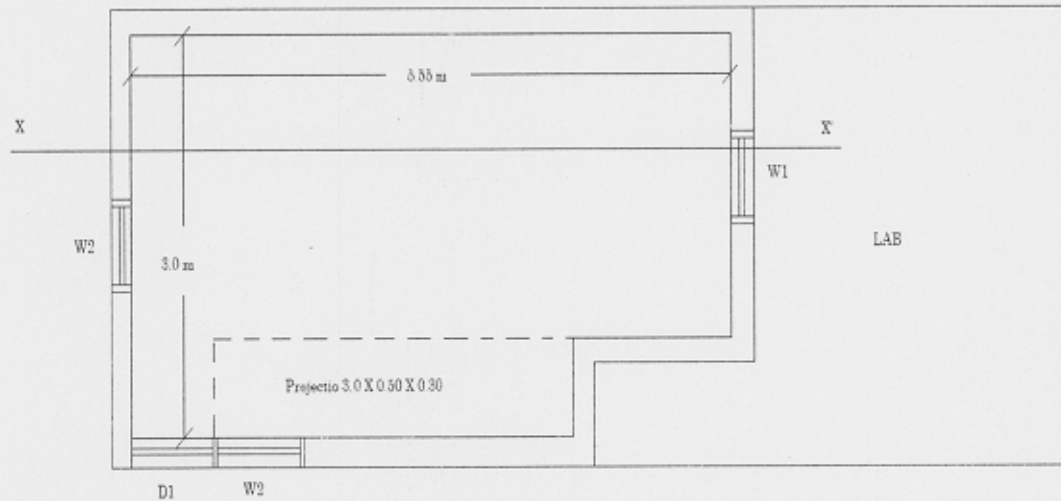

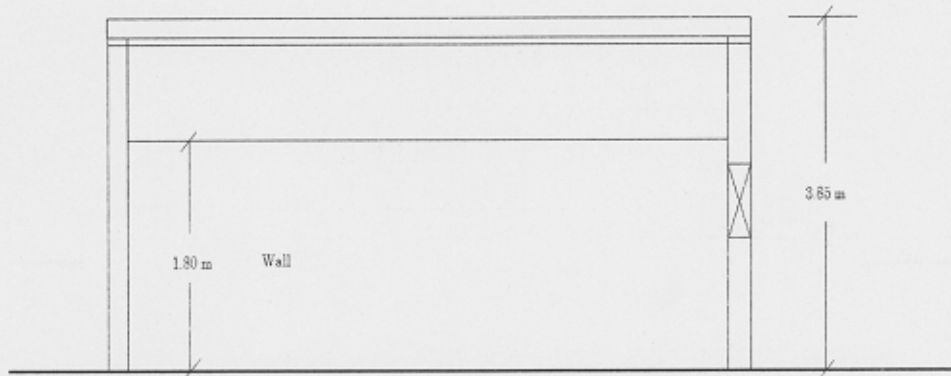
