

Telangana State Legislative Assembly on Monday passed a unani-mous resolution affirming the Congress government's commitment not to hand over control of comhand over control of com-mon projects of Srisailam and Nagarjunasagar to the Krishna River Manag-ement Board (KRMB), until conditions put forth by the state are adhered to. The resolution was passed after a five-hour debate in the House, of accusations and counters

accusations and counters between the Congress and BRS on the issue of who agreed to hand over pro-jects to the KRMB. The Congress and BRS held congress and BKS held each other responsible for facilitating the KRMB to take over the projects. The resolution passed by the House read, "In view of the historical injustice

and the current situation, the House hereby resolves that the government of Telangana shall not hand over control of common projects to KRMB unless the conditions put forth by the state have been ful-filled, which are as follows. Water sharing between Andhra Pradesh and Telangana shall be on the basis of catchment area, drought-prone area, basin population and cul-tivable area."

The other conditions put

forth by the state govern-ment included: "In-basin needs shall be met first on priority as per Krishna Waters Dispute Tribunal-I (KWDT-). Srisailam pro-ject was sanctioned as a hydroelectric project by the Planning Commission in 1962 for supplying 264 tmc ft to Nagarjunasagar project. Accordingly, MD-DL (minimum draw down level) of Srisailam shall be +830 ft as per KWDT-I award." As per KRMB operation protocols, the MDDL of Srisailam is 854 ft for irri-

gation and 834 ft for power generation.

A tmc ft of water refers to thousand million cubic feet, as much water the Hussainsagar holds when



it is full. "Outside basin diversions from Srisailam reservoir shall be limited to 34 tmc ft (15 tmc ft for Chennai water supply and 19 tmc ft for Srisailam Right Bank Canal) which were approved by the

Central Water Commission. The use towards drinking water shall be reckoned as 20 per cent of withdrawal towards con-sumptive use as stipulated by KWDT-I."

TN demand on Cauvery water nixed

K'taka must ensure natural flows at Biligundulu by releasing 1,000 cusecs per day for Feb

THE Cauvery Water Regulation Committee (CWRC) on Monday rejected Tamil Nadu's demand to direct the Karnataka government to release 7.6 tmcft of water that is due to the state.

The committee directed Karnataka to ensure the release of Cauvery water to ensure environmental flows of the river as per the final award of the Cauvery Water Disputes Tribunal (CWDT) modified by the Supreme Court.

As per the CWDT award, Karnataka must ensure the natural environmental flows at Biligundulu on the interstate border by releasing 1,000 cusecs per day (2.5 tmcft) for the whole of February to May period. For this, Karnataka doesn't have to release water from KRS, Kabini, Harini and Hemvathy. The four major Karnataka dams currently have around 37tmcft of water.

In the 93rd meeting of the CWRC held under its chairman Vineet Gupta, the commission told Tamil Nadu that there is no need to release any additional water for irrigation.



"Harvesting of crops has already started in Tamil Nadu and there is no requirement for additional water to irrigate crops," Gupta told this newspaper. Tamil Nadu officials, however, said the state needs water for late sowing of crops. The formal irrigation period of Tamil Nadu ended by January 31 and harvesting of crops has already started, sources said.

The commission also said northeast monsoon has reduced the demand for water in Tamil Nadu but Karnataka has been facing drought-like condition in the Cauvery basin. While Karnataka's Cauvery basin is dependent on southwest monsoon (June-Oct), which witnessed a short-fall, the catchment areas of Mettur reservoir in TN benefited from the northeast monsoon season (Oct-Dec), it said.

"After January 31, there is no need for extra water as harvesting of crops would start in February in TN while Karnataka needs to maintain the environmental flow of river," Gupta said. The next meeting of CWRC is scheduled for March 21.

BRS beats back Cong blame game

Launches scathing attack on govt for failing to protect Krishna projects, says TS' riparian right put at stake

The Bharat Rashtra Samiti (BRS) on Monday launched a determined on slaught against the government for its failure to safeguard the State's jurisdiction of the Nagarjuna Sagar Project (NSP) and nine of the 15 outlets of joint projects in the Krishna basin that were under its control so far.

Voicing concern over the government's ill-advised moves ever since the Congress came to power, it pointed out that the legitimate riparian right of the State was put at stake.

Welcoming the resolution introduced in the House by the government against handing over the common projects of Telangana and Andhra Pradesh in Krishna basin, BRS leader and former Irrigation Minister T Harish Rao called it the first major victory of the BRS party. The Congress government, within two months of coming to power, conceded the State's jurisdiction of the Krishna projects as well as their outlets to the Krishna River Management Board (KRMB).

He said the resolution was the culmination of the campaign stepped up by the BRS against the government's failure to defend its direct control over the projects and outlets. The government took a U-turn on its stand ahead of the public meeting at Nalgonda scheduled for Tuesday. The government version on Krishna water was replete with lies. The State's riparian rights over Krishna waters were strongly defended during the BRS regime under the leadership of K Chan-drashekhar Rao.


The BRS had consistently been making a strong case

for the injustice meted out to the State with the sharing of the river water between TS and AP at a 34:66 ratio. It had been insisting on sharing at least a 50:50 ratio though the State was entitled to a larger share. The State had strongly opposed the allotment of 299 tmc of Krishna water to Telangana as against 512 tmc to AP and mounted pressure for a review. The previous BRS government had made the State's stand on the jurisdiction of the joint projects amply clear at the 16th meeting of the Krishna River Management Board (KRMB).

Even at the second Apex Council, the State could spell out its stand and, as a follow-up, it wrote to the Ministry of Jal Shakti 27 times. The Pothireddypadu regulator widened, facilitating enhanced drawls from the Srisailam project, during the Congress rule in the undivided State. The Ray-alaseema Lift Irrigation project was also opposed strongly by the State during the BRS regime. The previous regime did not yield to the pressure to hand over the operational control of the joint projects. But the Congress government had given its concurrence to hand over them to the KRMB at the meeting convened by the Jal Shakti Sec-

retary on January 17.

In a bid to cover up its mistakes, the government was out to blame former CM and BRS chief K Chandrashekhar Rao for its illadvised moves. BRS member Kadiam Srihari came down heavily on the Congress government for conceding the projects to the KRMB and retracting its stand in the face of strong opposition from the BRS.

Resolution on projects our first victory: BRS

Telangana Assembly on Monday passed a resolution that the Srisailam and Nagarjuna Sagar projects on the Krishna river will not be handed over to the Krishna River Management Board (KRMB).

The BRS declared the State government's decision its first victory as the main opposition.

Taking to X, BRS working president KT Rama Rao said due to the pressure created on the Congress government following the 'Chalo Nalgonda' meeting being organised by the BRS in Nalgonda on Tuesday to protest the handing over of the Krishna river projects to the Centre, the Congress

government was compelled to introduce a resolution in the Assembly and clarify that these would not be handed over to the KRMB. "It's the first victory for the BRS as the principal opposition," he declared.

Former Minister T Harish Rao also termed the passage of the resolution as the victory of the BRS and the people of Telangana. He said the Congress government is trying to cover up its mistakes by passing the resolution, "However, it is unfortunate that the BRS was not given an opportunity to make a presentation on the issue in the Assembly. People must know the truth about the prevailing situation," he said

'Attention not given to Krishna basin'

HYDERABAD: Accusing the past government of failing to protect Telangana's interests in Krishna water Sharing, Irrigation Minister N Uttam Kumar Reddy said the Congress has resolved not to hand over the control of the Krishna projects to the Krishna River Management Board (KRMB).

To this effect, the Minister moved a resolution in the Assembly here on Monday and appealed to the members of all parties to extend their support. This was followed by an hour-long PowerPoint presentation by the Minister in the House.

The Minister charged that after Telangana's formation, sufficient attention was not given to the requirements of the Krishna basin. The past government, through an adhoc agreement in 2015, had agreed to 299 tmc of water for Telangana and 512 tmc for Andhra Pradesh, he said amidst objections from BRS members, who said it was false.

BRS members raise objections

Despite being detrimental to Telangana's interests, the past government had also proposed to hand over common projects, including the Srisailam and Nagarjuna Sagar, to the KRMB, he alleged, triggering objections from BRS members.

During the presentation, the Minister said from 2004 to 2014, 10,665 tmc inflows were registered in Srisailam and diversions of 737 tmc outside the basin. Similarly, after Telangana's formation, 8,993 tmc inflows were registered and diversions of 1,200 tmc, he said, pointing out that this was a gross injustice to Telangana.

"The diversions were more than united Andhra Pradesh due to the incompetent BRS government. Inflows got reduced and diversions increased," Uttam Kumar Reddy slammed.

The Minister also maintained that the past government did not claim 225 tmc of water for ongoing projects, including the Srisailam Left Bank Canal, Kalwakurthy LIS, Nettempadu LIS, Palamuru-Ran-

gareddy LIS and Dindi LIS, before the Krishna Water Dispute Tribunal. In addition to the existing projects covering 299 tmc, the ongoing projects were earmarked for the utilisation of 225 tmc and contemplated projects for 206 tmc.

Though there was scope for demanding 731 tmc, the past government agreed for only 299 tmc, he said, asking how BRS members would defend this negligence.
