





## **TERMS AND CONDITIONS OF LIMITED TENDER**

1. The supply of the items should be done as per quotation within 15 days from the date of issue of Supply order.
2. All the gauge posts should be well painted and scale marking with specified colors (for background white color and for scale marking black and red)
3. The supply of manufactured gauge posts should be as per drawing specification.
4. The vendors may supply the gauge post at all different 24 sites under this division as per direction of Executive Engineer.
5. The supply carried out by the firm shall be guaranteed. The undersigned reserves the right to tests the materials (Moisture Content, Density and bending strength etc.) as per Indian standard tests.
6. The material should be well seasoned and standard quality and free from all defects and if found not suitable the same shall be asked for replacement at his own cost.
7. The rates shall be kept valid for minimum period of 60 days from the date of opening of quotation.
8. The rates should be inclusive of all local taxes such as Service Tax/GST etc.
9. Rates of Service tax/GST should be mentioned as applicable.
10. The rate of works should be quoted both in figures as well as in words.
11. The quotation number with date of its opening has to be clearly mentioned on the top of the quotation and sealed cover.
12. The quantities mentioned are likely to increase or decrease at the time of placing of supply order.
13. Any correction in the quotation should be clearly attested.
14. Request for any advance payment will not be entertained.
15. The work carried out by the firm shall be guaranteed. The undersigned reserves the right to cancel/reject in part or full or any/all the quotation without assigning any reason thereof and without any financial involvement from either side.
16. Payment will generally be made via online mode through PFMS directly on the bank account of the bidder on production of bills.
