Subject: Offer of appointment to the post of Junior Engineer (Civil & Mechanical) in the Central Water Commission on the basis of JE Examination, 2023-regarding.

Dear candidate,

I am directed to say that on the basis of the result of JE Examination, 2023 conducted by the Staff Selection Commission, you have been selected for the post of Junior Engineer (C&M) in the Central Water Commission and are hereby offered an appointment to the Junior Engineer (C&M) post in Level-6 (Rs.35400-112400) of the Pay Matrix (pre-revised Grade pay Rs.4200/-). You will also be entitled to draw usual allowances at the rates admissible and subject to the condition laid down in the rules and orders governing the grant of such allowances in force from time to time. Your appointment will be purely on temporary basis subject to successful completion of the probation period.

2. This offer of appointment shall be subject to the following terms and conditions:-

- I. Your appointment to the post shall be governed by the relevant service rules and orders in force and the regulations made there under.
- II. The appointment is **provisional** and subject to verification of character and antecedents from the concerned authorities as per procedure laid in this regard.
- III. You will have to give an undertaking at the time of joining that if anything adverse comes out in the character and antecedents verification that would make you ineligible for appointment in the first instance, then you will be liable to be discharged from Government service forthwith without any further notice.
- IV. You will be appointed on probation, the period of probation being two years from the date of initial appointment. This will be further subject to the verification of your character and antecedents/Caste certificate/PwBD Certificate/income certificate/other claims wherever applicable. The period of probation may be extended at the discretion of the competent authority but the total period of extension of probation shall not, except where it is necessary, by reasons of any departmental or legal proceedings pending against you, exceed one year.

- V. Your appointment may be terminated at any time by one month's notice given by either side namely, the appointee or the Appointing Authority, without assigning any reason under Central Civil Services (Temporary Services) Rules, 1965 as amended from time to time. The Government, however, reserves the right to terminate the service of the appointee forthwith or before the expiration of the stipulated period of notice by making payment of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- VI. The above said appointment carries with it the liability to serve in any part of India or outside. The appointee will have to carry out such duties as may be assigned to him by the Competent Authority.
- VII. The appointee will subscribe to a new "Defined Contribution Pension Scheme" introduced vide Government of India, Ministry of Finance, (CGA) OM No.1(7)(2)/2003/TA/11 dated 7.1.2004 read with OM No.1(7)(2)/2003/TA/67-74 dated 4.2.2004 as amended from time to time.
- VIII. The appointee will be eligible for the benefits admissible under the Central Govt. Employees Group Insurance Scheme, 1980 on the terms and conditions contained therein.

3. If you are already in service in Central Government/ State Government/ PSU/ Autonomous Bodies/ Bank/ Corporation etc., then your appointment shall be subject to Vigilance clearance and relieving by the present employer.

4. The other terms & conditions of your appointment are as follows:-

- I. If the verification reveals that your claim with regard to your belonging to Educational Qualification and SC/ST/OBC (not belonging to creamy layer)/PwBD/EWS is false, your services will be terminated forthwith without assigning any further reasons and without prejudice to such action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
- II. A person shall not be eligible for appointment if he/she has entered into or contracted a marriage with a person having a spouse living, or if he/she having a spouse living has entered into, or contracted a marriage with any person provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to him and the other party to the marriage and that there are other grounds for so doing, grant exemption from the operation of this rule.
- III. You shall intimate immediately the change, if any, in your religion after appointment to the appointing/administrative authorities concerned.
- IV. Taking of an oath of allegiance/faithfulness to the Constitution of India (or making a solemn affirmation to that effect) in the prescribed form.
- V. You shall submit a Medical Certificate of fitness from a Civil Surgeon or a District Medical Officer or a Medical Officer of equivalent status, in the prescribed Proforma to the concerned Superintending Engineer (C) along-with the statement & declaration form duly completed.
- VI. You shall submit a Character Certificate regarding verification of your character and antecedents, in the prescribed forms, by District Magistrate or Sub-Divisional Magistrate without any adverse remarks against you which would render you unfit for Government service.

5. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have wilfully suppressed any material information, he/she will be liable to removal from service and such other action as the Government may deem necessary.

6. **If you accept the offer of appointment on the above terms and conditions, you shall join the post by reporting to Superintending Engineer (Coordination) of the allotted office of the Central Water Commission as per Annexure-I under intimation to the undersigned within THIRTY (30) DAYS from the date of issue of this offer of appointment.**


7. At the time of reporting, you are requested to furnish the following documents:-

- b. Original certificate relating to date of birth; age relaxation, if any;
- c. Original certificate(s) of educational qualification, experience if any, and other technical qualification;
- d. Original character Certificate in the prescribed form from two Gazetted Officers / District Magistrate/ Sub-Divisional Magistrate;
- e. Original Medical Certificate of fitness from a Civil Surgeon or a District Medical Officer or a Medical Officer of equivalent status, in the prescribed Proforma;
- f. Original certificate in the prescribed form in support of candidate's claim to belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes;
- g. Undertaking as in para 2(III) above;
- h. Declaration regarding marital status;
- i. Declaration regarding OBC (Non-Creamy Layer) status as on crucial date (if applicable);
- j. Discharge certificate in the prescribed form of the previous employment, if any.

8. It is also informed that this offer of appointment may lapse automatically in accordance with the DoPT's OM No.35015/2/93-Estt.(D) dated 9.8.1995, in case you fail to join the respective office of Central Water Commission. No separate communication to this effect will be sent. Further, this offer of appointment does not in any way involve any commitment for your appointment to the post.

9. You will not be entitled to any travelling allowances (**except those who are posted in BOBO, Shilong & BBO, Guwahati**) for joining the service on appointment, unless you are holding a permanent appointment under the Central or State Government.
