Further posting as AD-II/SDE of the official will be decided by the concerned SE (C) of the field organization and Under Secretary, Estt- V Section of the Commission, as the case may be.
3. Officials /officers deputed on election duty will be relieved in consultation with District Election Officer.
4. Officers deputed on election duty may be relieved after the officers are relieved of their election duty by ECI. The officers should get themselves properly relieved by their Controlling Officer before proceeding to their new place of posting
5. The promotion of the above officers will be effected from the date they assume charge of the higher post **within 30 days from the date of issue of this order**. No request or representation to forgo the promotion shall be entertained after 30 days of the issue of this order.
6. Junior Engineers who forgo their promotion to the grade of AD Gr.II/ SDE in the current vacancy year 2023 will not be considered for
