Please provide state- wise and FY-wise works taken up, the status of the works taken up under various components of Pradhan Mantri Krishi Sinchayee Yojana since the inception of the scheme	During the year 2015-16 Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) was launched with the aim to enhance physical access of water on form and expand cultivable area under assured irrigation, improve on farm water use efficiency, introduce sustainable water conservation practices, etc. PMKSY is an umbrella scheme, consisting of two major components being implemented by this ministry, namely Accelerated Irrigation Benefits Programme (AIBP) and Har Khet Ko Pani (HKKP). HKKP, in turn consists of four subcomponents being, Command Area Development & Water Management (CAD&WM), Surface Minor Irrigation (SMI), Repair, Renovation and Restoration of Water Bodies, and

Ground Water (GW) Development component. However, CAD&WM sub-component of HKKP is being implemented paripassu with AIBP.

In addition PMKSY also consists of two components being implemented by other Ministries. Per Drop More Crop (PDMC) component is being implemented by Department of Agriculture and Farmers Welfare. Further, Watershed Development component (WDC) of PMKSY is being implemented by Department of Land Resources.

During 2016-17, Ninety-Nine (99) ongoing Major/Medium Irrigation projects (and 7 phases) spread in 17 States and two Union Territories (Jammu & Kashmir and Ladakh) were included under PMKSY-AIBP.

Out of 99 projects and 7 phases (total -106), 54 MMI projects have been reported as completed as on date. The year-wise completion of projects is as under:

Further in December, 2021, implementation of PMKSY for the period of 2021-22 to 2025-26 has been approved by Govt. of India. Under the extension of PMKSY Ground Water component under PMKSY-HKKP has been provisionally approved for 2021-22 (extended subsequently for completion of ongoing works and liabilities), while Per Drop More Crop component is now no longer under the PMKSY

Eight (08) new MMI/ERM projects have been included in the scheme since 2021.

The list of new projects included under PMKSY-AIBP since 2021 is enclosed as **Annexure-A**.

The State-wise and FY-wise works taken up, the status of the works taken up under SMI & RRR of water bodies components of Pradhan Mantri Krishi Sinchayee Yojana-Har Khet Ko Pani since the inception of the scheme i.e 2015-16 onwards is furnished in "Annexure -B"

Government of India approved a scheme of National Projects for implementation during XI Plan. National Projects are provided financial assistance for cost of irrigation & drinking water component in the form of central grant. Scheme of National Projects are either funded under umbrella scheme of PMKSY or as per specific direction of Union cabinet/ Act of Parliament.

Till date, Government of India has included 16 projects under the scheme of National Project Out of that only 8 projects are under execution stage. Details of the 8 National Projects under execution is attached as "Annexure – C"

Out of the 106 (total) prioritized projects 8 Major and Medium Irrigation projects are from the state of Andhra Pradesh.

The detailed information of year wise CA Released, Expenditure Incurred, District Benefitted, Latest estimated cost etc. of the above projects is enclosed as **Annexure-1** and **Annexure-2**.

FY-wise CA released and expenditure made by the state of Andhra Pradesh under RRR of Water Bodies component the inception of the scheme i.e 2015-16 onwards "Annexure -3". There is no SMI scheme is being implemented under PMKSY-HKKP in the state of Andhra Pradesh.
