1.	Can a state government in our country design, construct and execute irrigation projects without the due approval or consent of the Central Water Commission?	As per CWC Guidelines for Submission, Appraisal and Acceptance of Irrigation and Multipurpose Projects, 2017, The concerned state government in the initial stage submits preliminary report (PFR) which are required to establish soundness of the project proposal. The project proposal is examined and if found acceptable, CWC conveys "In-principal" consent to the state government for preparation of Detailed Project Report (DPR). The DPR thus prepared is examined in CWC. CWC will primarily examine Hydrology, inter-state aspects, irrigation planning and economic viability in the DPR. In state where Central Design organisation (CDO)

States with CDO need to submit the certificate indicating planning and design/safety aspects have been examined by the CDO under the state Water Resources Department.</p> <p>The said guidelines are applicable to major and medium irrigation and multipurpose projects on inter-state rivers or their tributaries.</p>
2.	Has the Central Water Commission inquired about the damages that were reported in the Kaleshwaram Lift Irrigation Project in Telangana?	Requisite information sought is not available in WP&P wing of CWC
3.	<p>Is it true that the Central Water Commission did not approve the designs and other technical aspects of the Kaleshwaram Lift Irrigation Project in Telangana?</p> <p>Please furnish the technical approvals granted by the Central Water Commission to the Kaleshwaram Project in Telangana.</p>	<p>As per CWC Guidelines for Submission, Appraisal and Acceptance of Irrigation and Multipurpose Projects, 2017, design aspects need not be examined by CWC, in case, State Govt furnish certificate in the prescribed proforma indicating that the planning & design/safety aspects have been examined by the Central Design Organization (of the State Govt).</p> <p>The State has submitted certificate from Chief Engineer, Central Design Organization, Irrigation and CAD Department, Govt. of Telangana, that the Kaleshwaram project has been examined in the Central Design Organization with reference to preparation of DPR including Survey and Investigations etc. (Copy enclosed as Annexure-I)</p> <p>Hence, no detailed examination of design aspects have been carried out in CWC. However, only planning aspects of the project have been examined by the BCD (NW&S) Directorate, of CWC.</p> <p>Further, the Kaleshwaram Project (for 2 TMC) was considered and accepted in 136th meeting of Advisory Committee of DoWR, RD & GR held on 06.06.2018.
