In order to supplement their efforts, Government of India provides technical and financial assistance to State Governments to encourage sustainable development and efficient management of water resources through various schemes and programmes such as Accelerated Irrigation Benefits Programme (AIBP) etc., and Pradhan Mantri Krishi Sinchayee Yojana (PMKSY).</p> <p>The Accelerated Irrigation Benefit Programme (AIBP) was started by Government of India in 1996-97 (During VIII Plan). The programme was started to provide Central Assistance (CA) to the major and medium irrigation projects which are in advance stage of construction. Subsequently CA to minor irrigation schemes was also included in the programme and has</p> |

been continuing since then by continuing the programme in the subsequent Five Year Plans.

297 major and medium irrigation projects have been benefitted under this programme. as out of these 143 major and medium irrigation projects have been completed and five projects have been deferred by the concerned State Governments

Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) was launched by Government of India during the year 2015-16, with an aim to enhance physical access of water on farm and expand cultivable area under assured irrigation, improve on farm water use efficiency, introduce sustainable water conservation practices etc.

The extension of PMKSY for the period 2021-22 to 2025-26 has been approved by Government of India.

PMKSY is an umbrella scheme consisting of two major components being implemented by the Department of Water Resources. River Development & Ganga Rejuvenation, namely. Accelerated Irrigation Benefits Programme (AIBP) and Har Khet Ko Pani (HKKP). HKKP, in turn, consists of four sub-components: Command Area Development & Water Management (CAD&WM), Surface Minor Irrigation (SMI), Repair, Renovation and Restoration (RRR) of Water Bodies and Ground Water (GW) Development component.

During 2014-15 to 2015-16 total Central Assistance (CA) of Rs.4233.49 crore have been released for the projects included under AIBP scheme.

During 2016-17 to 2023-2024, total Central Assistance (CA) of Rs.14,743.56 crore have been released for the projects included under PMKSY-AIBP scheme

Govt. of India has also approved a Special Package for Maharashtra, which provides Central Assistance to complete 83 Surface Minor Irrigation (SMI) projects and 8 Major / Medium Irrigation Projects in drought prone districts in Vidarbha, Marathwada and rest of Maharashtra. During 2018-19 to 2022-23, The funds sanctioned under Special Package for Maharashtra state for both MMI & SMI during 2018-19 to 2023-24 is Rs. 2837.69 Cr

In addition to this, Govt. of India has also sanctioned the relining/reviving of Rajasthan Feeder
