**Subject: Nomination of STS level officer of CWES (Gr. 'A') to be posted as Domain Expert (Level -11) in in ICR-ER, MHA, New Delhi, on deputation basis - regarding.**

Sir,

With reference to the above mentioned communications, I am directed to state that the Disaster Management Division (DDM), MHA is in process of setting up an Integrated Control Room for Emergency Response (ICR-ER) under MHA as a single point contact center to monitor disasters on Pan India basis. The proposed ICER-ER is likely to be inaugurated by Hon'ble Minister for Home Affairs in the last week of August, 2024.

2. Thus, DDM, MHA has requested this Department to place service of a suitable STS level officer of CWES (Gr. 'A') for appointment to the post of Domain Expert (Pay Level-11) in ICER-ER, MHA, on deputation basis. The period of deputation would be 3 years and the place of posting would be at ICR-ER control room in NDCC-II building, Jai Singh Marg, New Delhi-110001. The job description of the post of Domain Expert is as follows:

- i. To liaise with CWC HQrs and CWC Field Stations on behalf of MHA and obtain near real-time data on reservoirs, dams, rivers and other critical water bodies from disaster perspective.
- ii. To analyze CWC inputs on flood forecasting, for issuing alerts from ICR-ER.
- iii. To provide required inputs to NRSC team for running DEM (Digital Elevation Model), Digital Surface Model (DSM), Digital Terrain Model (DTM) to predict floods and other Hydro-meteorological disasters to enable better evacuation plans during Monsoon season, Cyclones, Cloud bursts, etc., for disaster preparedness.
- iv. Interpretation of CWC bulletins/ Advisories.
- v. Coordination with other domain experts from IMD and NRSC placed in ICR-ER.

2.1 As far as method of recruitment to the post of Domain Expert in ICR-ER, MHA is concerned, please note that a Selection committee has been constituted in MHA with AS, MHA as its Chairman. The Selection Committee will pursue the nominations of all the applying candidates and conduct personal interviews for final selection of appropriate candidates of ICR-ER.

2.2 Further, the pay will be regulated as per the extant guidelines of DoPT on deputation. The Salary will be paid from Consolidated Fund of India. The salary and associated expenditure of the personnel on deputation to ICR-ER will be debitable to Major head "2052-Secretariat General Services, 00.090 Secretariat (Minor Head), 03-Ministry of Home Affairs, 03-02-General Administration, 03.02.01-Salaries" under Demand No. 49, Ministry of Home Affairs.

3. In view of the above, you are requested to nominate suitable officers from STS of CWES (Gr. 'A') drawing pay at Level-11, for deputation in ICR-ER, MHA, New Delhi in Pay Level-11, at the earliest so that DDM, MHA may be informed accordingly.
