- (a)whether the National Commission for Scheduled Tribes has submitted report / recommendations to the Government on the plight of tribals affected /displaced by the Indira Sagar Polavaram Project in Andhra Pradesh and if so, the details thereof;
- (b) whether the Commission has visited all affected areas / States;
- (c) if so, the details thereof along with the authorities who were consulted by the commission in this regard; and
- (d)the details of reference issued by the Government to the Commission along with the other steps taken by the Government to mitigate the suffering of affected tribals of the area?

Will the Minister of TRIBAL AFFAIRSbe pleased to state:-

ANSWER

- (a) to (c)National Commission for Scheduled Tribes under the Chairmanship of Chairmage, 2 of 20 NCST visited few villages and met Scheduled Tribe persons / families affected on account of Polavaram Irrigation Project in Andhra Pradesh on 26th to 28th March, 2018. Thereafter, the Commission met the Chief Minister of Andhra Pradesh and other Senior Officers dealing with the Project. Based on the interaction with the Polavaram Irrigation Project affected people, the Commission prepared a Special Report which comprises important features of Polavaram Irrigation Project, details regarding land acquisition and rehabilitation and resettlement, issue raised in the various representations received from the project affected people and the Commission's recommendations / advises for better rehabilitation and resettlement of the project affected Scheduled Tribes families. The Commission submitted the report to the Hon'ble President on 03.07.2018. Recommendation of the Commission is at Annexure.
- (d)The Ministry of Water Resources, River Development and Ganga Rejuvenation vide their order dated 12.09.2017 has constituted a Committee headed by Secretary (Tribal Affairs) for exclusive monitoring mechanism for Polavaram Project at National Level. The Terms of Reference of the said Committee inter-alia includes to ensure finalization of traditional community and individual forest rights of tribals and villages in the forest area of the Polavaram project in coordination with Agencies / Authority implementing Rehabilitating and Resettlement activities of the project.

ANNEXURE REFERRED IN REPLY TO POINT (a) to (c) IN RESPECT OF LOK SABHA UNSTARRED QUESTION NO. 788 DATED 23.07.2018 ASKED BY SHRI BALABHADRA MAJHI, HON'BLE MEMBER OF PARLIAMENT REGARDING 'TRIBALS AFFECTED BY POLAVARAM DAM'

RECOMMENDATIONS / ADVICE OF THE COMMISSION

- (i)The Commission, while interacting with affected Scheduled Tribe people was informed that in many cases, the alternative land given to them in lieu of the acquired land is not cultivable. Either it is rocky terrain or there is no water. The Commission, therefore, recommends that the State Government should provide only land fit for agriculture to PDFs/ PFs within the command area of Polavaram Irrigation project with proper irrigation facilities.
- (ii) The Commission noted that many ST people without land holdings were also shifted. They were hitherto depending on minor forest produces for their livelihood. Now, they are shifted and deprived of their livelihood. The State Government needs to take care of them by providing alternative means of livelihood.
- (iii)When the Commission visited Iddikulakotta village, complaints were received stating that in that village, many newly constructed houses were destroyed due to flash flood and so far the destroyed houses have not been re-built. The Commission recommended that the destroyed houses should be re-built immediately to mitigate the sufferings of ST people.

- (iv)The compensation packages in respect of Polavaram Irrigation project need to be Page 3n of 20 suo-moto basis by the Government of Andhra Pradesh keeping in view the observations and modalities suggested by the Hon'ble Supreme Court of India in Special Leave Petition (SLP) NO. 6933 of 2007 in the case of Mahanadi coalfields Ltd Versus Mathias Oram and others. The Commission feels that a similar Scheme as per the above Supreme Court order will help the Scheduled Tribe people affected by Polavaram Irrigation Project as their right to fair compensation. Further, the provisions of the Right to Fair Compensation, Transparency in Land Acquisition, Rehabilitation and Resettlement Act be kept in mind and used to the advantage of the Tribals in the best possible manner.
- (v)While awarding compensation in respect of tribal people, "land for land" policy should be followed to the maximum extent. In this regard, the ceiling of 2.5. acres of land should be waived in case of ST people, and they should be provided equal or at least 2.5 acres of land within the Command Area of the Polavaram Irrigation Project.
- (vi)In the resettlement colonies, focus/emphasis needs to be given for creation of social infrastructure like setting up of Colleges, University, Stadiums, Medical College on the pattern of AIIMs, Art and Music academies/centers, etc. in addition to their entitlement. The State Government Should make adequate provision of land for creation of such infrastructure facilities through outright purchase, if necessary.
- (vii)The State Government should consider the entire rehabilitation and resettlement work is undertaken through R&R Commissioner as single point responsibility as well as accountability for R&R, while the actual implementation can be undertaken by other line departments/agencies.
- (viii)The State Government must ensure that R&R work is completed and compensation paid to the project affected as well as project displaced families at least four months prior to submergence or commissioning of the project or their displacement, whichever is earlier.
- (ix)The State Government should consider developing an industrial estate/hub adjoining the resettlement area to provide employment and economic opportunities to the displaced families. Both the State Government as well as the Central Government should consider declaring this industrial estate as tax free with a tax holiday for 10 years. There should be a condition that only the displaced people from the Polavaram Irrigation Project will be given employment for non-managerial jobs in this industrial estate.
- (x)The Commission apprehended that once the dam project is physically completed and affected people are shifted to new places, the concerned R&R officials will be transferred to new responsibilities and it is likely that the people rehabilitated will be left to their destiny and will have to fend to themselves without any supporting institutional mechanism. Commission, therefore strongly recommends that there should be a dedicated team of R&R officials to be stationed in rehabilitation area to oversee the developmental activities and other welfare measures for a period of at least 5 years from completion of the project.

- of the reservoir spreads beyond Andhra Pradesh State boundary into the states of Chhattisgarh and Odisha. These states shall be affected due to backwater effect during floods.
- 2. As per recommendation of NITI Aayog, Water Resources Department (WRD), Government of Andhra Pradesh (GoAP) is executing Polavaram Irrigation Project (PIP). The R&R Policy implemented for the Polavaram Irrigation Project (PIP) upto 01.01.2014 is as per GoAP G.O.Ms.No.68 dated 08.04.2005. Later, "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (RFCTLARR) Act, 2013 is being implemented for Polavaram Irrigation Project in State of Andhra Pradesh.The Govt. of Odisha filed Original Suit before Hon'ble Supreme Court regarding R&R in Orissa. The matter is subjudice at present.
- 3. As per GoAP, till date 12% of R&R has been completed in respect of Polavaram Project.

Observations:

The Commission after going through the records, holding public meetings, visiting the tribal habitations, the colonies meant for the displaced families, witnessing the plight of the tribal people on the spot express serious concern over the inaction and negligence attitude of the State Authorities. The major observations are as follows.

- 1. During the visit, the Commission has observed that the new habitations lack basic amenities like drainage system, roads, drinking water, sanitation and electricity. The villages such as Yerravaram village is found without potable drinking water facilities and drainage system. The villages such as Yerravaram, Pedabhimunipalli-2 &3, P.Narayanpuram found without proper roads and electricity.
- 2. The Commission has received number of complaints from the tribal habitants that the houses constructed are being leaked at ceiling and walls of the constructed houses are with cracks. In this regard the Commission has physically verified the veracity of the allegations of the complainants and it is found to be true. It is also found that the Kitchen rooms lack proper window for ventilation and the some of the houses are found without doors in Moolpeta Village. Further the allottees have requested to construct the boundary wall around their houses and to raise the pit wall with stairs. The Commission has come to know that all the PDFs have got 379.25 square feet of land for housing.
- 3. The land to land issue remains a major cause of concern raised by the PDFs, they have alleged that most of them are deprived of their right. On the other hand, those who have received the land have complained to the commission that the land provided to them is a far away from their habitations, and some others have pointed out that the land provided them is a revenue land which is not fit for cultivation and requested for the same to be converted into agriculture land.
- 4. At present the Compensation amount is being paid to each PDFs is Rs. 6,86,000 and Rs.7,50,000 respectively as per the eligibility. When the Commission interacted with the public at various places, the Commission has received large scale demand that in addition to the Compensation under the applicable Act additional amount of Rs.10, 00,000 (Rs.Ten Lakh Only) as promised by Govt. of Andhra Pradesh has not yet been disbursed.





RECOMMENDATIONS:

After making painstaking exercise, the Commission observed serious violation of tribal rights and express anguish over the delaying attitude of the Government Authorities. The Commission also takes note of the failure on the part of State Authorities in rehabilitation and resettlement of the displaced tribal families. The inaction and negligence of the State Authorities is not only painful but also violates the constitutional provisions meant for the safeguard and welfare measures for the tribal people. The Commission hereby recommends the followings for timely action.

For the Government of Andhra Pradesh- The compliance report to be sent to the Commission by the Chief Secretary of Andhra Pradesh within four weeks.

- The Commission recommends to speed up the rehabilitation process to ensure that
 the all the PDFs shall get their legitimate dues The State must ensure the
 compensation and R&R Packages under The Right to Fair Compensation and
 Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and
 its Schedules to each and every PDFs and also in each of the new R&R
 settlement colonies.
- 2. The Commission is constrained to recommend the quality of Construction of dwelling houses meant for the PDFs must be ensured with ventilation, doors and windows. The cracks on the walls and leakage of water from the roof ceiling must be immediately repaired with yearly maintenance. This must be supervised and monitored by the Rehabilitation commissioner of the project. His office shall receive complaints and take steps to see that the issues are addressed within ten days,
- Since the basic amenities are absent in the new habitations it is recommended that the electricity, supply of potable drinking water, drainage system, road and communication must be ensured to the residents of the colonies/habitations with immediate effect in compliance of the schedules to Act 30 of 2013,.
- 4 So far as the habitations lack system/space/facilities/ambience to facilitate the tribal culture and tradition, the Commission recommends the State must ensure by all possible means to preserve and promote the tribal life style with sanctity of their culture and tradition. The State must encourage the Traditional Knowledge System of the tribal people and make sure the same remains intact since the R & R

Colonies are not in consonance with the Policy, i.e. exactly in the same shape of the original tribal habitations.

- 5 It is also important to take note of the fact that the habitations lack Anganwadi centers and Schools. Therefore the Commission recommends that the same must be functional in compliance with the COVID-19 guidelines before the communities are moved out.
- 6 The Land to Land dispute is a persistent problem among the PDFs. The Commission takes serious note of the same and recommends that the Land must be ensured to the Tribal PDFs which must be cultivable and near to their habitations before the communities are moved out.
- 7 The Commission recommends health care, maternity care and child care centers in each and every habitation.
- 8 The Commission recommends the State must ensure to set up skill development programmers for the youth and to generate more employment opportunities for the educated mass.
- 9 Since there are cases where the eligible PDFs have been deprived of justice the Commission recommends for re-survey of the PDFs as claims of many eligible families have been rejected without due verification by the Authorities.
- 10 Since the Tribal communities have complained of non-settlement of individual and community rights under ROFR Act. Under FRA, the Commission recommends that their claims must be settled first. Appropriate inquiry, meetings of Gram Sabha, Survey etc must be taken up forthwith. If this is done the claims can be settled in course of time even if the tribal's move out to new colonies. If this is not done, after one year there will be no tribal available on ground in the original habitation and the forest will be submerged. Before this submergence the survey meetings, inspection of community resources documentation shall be completed.
- 11 The Commission recommends that the Authorities to conduct CENSUS and SURVEY as in each village forthwith to finalise the list in Gram Sabhas. This will be the basis for distribution of left out benefits even if the villages are submerged and tribal's move to new settlements. The same should be used for villages which may get benefit under old Land Acquisition Act, 1894 and GO 68 which deals with rehabilitation. If this survey under section 16-19 is not done now, the tribals will lose





the benefits forever as they will be scattered, resulting the beneficiaries will lose their identity forever.

- 12 The Commission recommends the State to implement in letter and spirit the relevant Legislation i.e. Act 30 of 2013 gives detailed procedure to be followed for R&R. Section 16, of the Act says that there shall be SURVEY and CENSUS of the affected families. Publication of Scheme. Review is to be done under Section 17. Section 18 and 19 speak about the Gram Sabha being consulted etc. Since these aspects are not taken care by the State Authorities, the Commission recommends completing the formalities on top priority.
- 13 The Commission hereby recommends that the Government must ensure Community Forest Rights in Project Affected Areas before finalization of compensation to the tribals as per the FRA and MOTA guidelines. It must also ensure, no eviction should take place till the process of recognition and vesting of Forest rights under the Forest Rights Act and in consonance with the MOTA Guidelines.
- 14 The ST PDFs have not been properly represented at SDLC and DLC therefore the Commission recommends for the inclusion of ST PDFs in the District Level Committees.
- 15 There is an urgent need to trace and compensate and properly rehabilitate the landless PDFs and their list must be separately maintained for ensuring them complete justice to them.
- 16 It is hereby recommended that the State of Andhra Pradesh to ensure additional Compensation amount of Rs.10, 00,000 (Rs. Ten Lakh Only)as promised by Govt. of Andhra Pradesh over and above the amount paid to them under the applicable Acts. Since the R & R process is moving at a snail's pace the same needs to be taken up on top priority. The PDFs from ST Community should be ensured with timely rehabilitation before their original villages are submerged.
- 17 Since the Commission feels that grievance management system of the State is poor, it is recommended that the Officials must visit the areas to address the grievances on a regular basis, in a timely manner(preferably on Wednesday or Thursday every week) with prior notice to the villages.).
- 18 The Commission recommends the State to ensure holistic and sustainable development of the tribal people affected by the Polavaram Project.

Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST on the representation from Smt. Kavuluri Seethamma has alleged that the Koya community is being affected by the Polavaram Project, but the government has not conducted a survey to determine the extent of the damage and compensation needed for those affected.

Date of the Sitting: 11.05.2023

The Commission received a representation on 28.04.2022, from Smt. Kavuluri Seethamma alleging that the Koya Community is being affected by the Polavaram Project, with their land being submerged. She expressed concern that the government has not conducted a survey of the affected areas to assess the extent of the damage and the compensation that should be provided to those affected. She further requested that the government take into account the concerns of the affected communities and ensure that their rights are protected.

The NCST vide notice dated 24.05.2022 has referred the matter to the Commissioner, Water resources department, Andhra Pradesh and the District Collector, West Godavari to furnish the facts and comments within 30 days from the receipt of the notice. No reply was received from the authority.

Subsequently Summon was issued to Dr. Sreedhar Cherukuri, Commissioner of rehabilitation and resettlement (R&R) Water resources department, Govt of Andhra Pradesh, Shri V. Prasanna Venkatesh, Collector & District Magistrate, Elluru District and Smt. P. Prashanthi, Collector & District Magistrate, West Godavari District on 02.05.2023.

In the hearing held on 11.05.2023 Dr. Sreedhar Cherukuri, Commissioner of rehabilitation and resettlement (R&R) Water resources department, Govt of Andhra Pradesh was present. Shri V. Prasanna Venkatesh, Collector & District Magistrate, Elluru District and Smt. P. Prashanthi, Collector & District Magistrate, West Godavari Districtdid not appear.

Dr. Sreedhar Cherukuri, Commissioner of rehabilitation and resettlement (R&R) Water resources department, Govt of Andhra Pradesh informed the Commission that due to heavy rains and floods in the monsoon season of 2022, the proposed survey could not be conducted as most of the villages (650 villages in 44 Mandals) mentioned in the petition became inaccessible. Consequently, the final report could not be submitted to the Commission. In reference to this, the Special Collector (LA) of the Polavaram Irrigation Project in Rajamahendravaram has submitted a detailed report

based on the findings of the Special Deputy Collector (LA), Polavaram Irrigation Project, RMC Unit-II, Eluru. The report includes observations made during inspections of lands in various villages, particularly those located above the Full Reservoir Level (FRL) as determined by the Irrigation Department.

In case any inaccessible lands are found, a Revised LP Schedule will be obtained from the Irrigation Authorities, and necessary action will be taken by the Land Acquisition Officer. The report also addresses specific pleas made by individuals regarding land possession and title claims. However, it is revealed that some of the lands are classified as Forest lands and the individuals have not produced the required documentation claiming ownership. Additionally, certain individuals recorded as pattadars (landholders) have not been issued or assigned any D-Form Patta. Further authority requested that the Commission to provide a three-month extension to confirm eligibility, undertake further necessary actions, pass awards, pay compensation if deemed eligible, and submit a report to the Commission.

The Commission has expressed serious displeasure regarding the delay in conducting the survey and further observed that proper verification has not been conducted by the administration and that they have also not followed the due procedure as mentioned under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 and Rules, 2012 in ensuring the Individual Forest rights to the Scheduled Tribes.

After the hearing, the Commission recommends the followings: -

 The Commissioner of Rehabilitation and Resettlement (R&R) of the Water Resources Department, Government of Andhra Pradesh, will ensure that the survey is completed within three months. They will also ensure that the land rights of all affected families are settled, along with the compensation, after verification. In addition, he will also furnish the copy of R&R policy to the commission

The Commissioner of Rehabilitation and Resettlement (R&R) of the Water Resources Department, Government of Andhra Pradesh, will submit the Action Taken Report with compliance of the recommendations to the commission within 3 months to the commission.

I respectfully submit that the National Commission for Scheduled Tribes under the Chairmanship of the Chairperson (NCST) visited a few villages and met Scheduled Tribe persons/families affected on account of the Polavaram Irrigation Project in Andhra Pradesh from 26-03-2018 to 28-03-2018. The NCST has made recommendations for better rehabilitation and resettlement of the projectaffected Scheduled Tribes families. however, no steps in this regard have been taken by the Union Government. I respectfully submit that NCST has issued a Report and Recommendations on 13-09-2021 under Article 338A (5) of the Constitution of India with respect to the Schedule Tribes affected on account of the Polavaram Project. The Commission observed serious violations of tribal rights and also expressed anguish over the delaying attitude of the Government Authorities. The Commission has recommended speeding up the Rehabilitation process to ensure that all the PDFs shall get their Legitimate dues among the other recommendations made in this regard. I respectfully submit that I have applied RTI vide CWCND/R/E/23/00150 dated 16/05/2023 seeking information regarding the number of SC and ST Project Displaced Families (PDFs) yet to receive the R&R Package as of today in connection with Polavaram Project at 45.72 m (Full Reservoir Level). The CWC replied on 16-06-2023 that only 8,050 of 56,504 ST PDFs and only 763 of 7180 SC PDFs have been shifted to date. That is, 14.24% of ST PDFs and 10.62% of SC PDFs of the total have shifted so far. Therefore, there is still a substantial number of PDFs in SCs and STs that are to be rehabilitated in the future for which only a meager amount of Rs 698.54 Crores is available as the final amount for reimbursement regarding the Polavaram Project. Please implement the recommendations of the NCST regarding Rehabilitation and resettlement compensation packages in connection with Polavaram Project of Andhra Pradesh.
