**विषय: Shifting H.O. Sites के संबंध में ।**

1. Regional Chief Engineers of CWC have been authorised regarding shifting of sites within their jurisdiction, vide letter no T-75075/43/2020-RMC Dte dated 19-04-2023. However, decision regarding closure or opening of new stations rests with CWC HQrs.

2. It has been observed that hydro-meteorological stations are required to be shifted depending upon new situations viz., construction of water resources projects or whenever technical reasons like back water issues etc are observed. Sometimes stations are also required to be upgraded in respect of various parameters whose data is being observed.

3. In continuation to CWC letter dated 19-04-2023, I am therefore now directed to convey that the regional Chief Engineers are authorized to take final view on the issues related to:

(i) Shifting of hydro-meteorological stations within a distance of few km upstream or downstream located on the same river, and

(ii) Upgradation and downgradation of sites by addition or deletion of parameters at hydro-meteorological stations in respect of which data is being observed (eg., G upgradation to GD or GDSQ down-gradation to GQ)

However, all other cases relating to shifting of stations viz., shifting of stations on other river(s) in same or different basin or opening a new station in lieu of already closed station, shall continue to lie in the competence of CWC HQ.
