6. The rates should be inclusive of all local taxes such as Service Tax/GST etc.
7. Rates of Service tax/GST should be mentioned as applicable.
8. The rate of works should be quoted both in figures as well as in words.
9. The quotation number with date of its opening has to be clearly mentioned on the top of the quotation and sealed cover.
10. The quantities mentioned are likely to increase or decrease at the time of placing of supply order.
11. Any correction in the quotation should be clearly attested.
