- 4. Approval for the Input/ Reply to the <u>STARRED</u> Parliament Questions must be obtained from the Chairman, CWC. The respective Organisation Head to obtain the approval of the Chairman directly through respective Wing Head.
- 5. Prior to the briefing meeting on <u>STARRED</u> Parliament Questions in Ministry, the concerned Organization/ Directorates must provide a folder to the Chairman, CWC, containing the approved reply of CWC along with supplementary notes. Additionally, the draft/ final response prepared by the Ministry should also be obtained from the concerned SMD of Ministry and presented to the Chairman, CWC in a folder before the briefing meeting.
- 6. Organisation Head while sanctioning Leaves to ensure that the alternate arrangement is in place to avoid any disruption in session work.
