Subject: Delegation of enhance power to Chief Engineer, NWA, CWC Pune for items related to training programmers –reg.

In suppression of earlier office order No- G-17014/1/2022-O&M/I/187541/2024 dated 25.10.2024 reference is invited to the Ministry of Water Resources, RD &GR Order No A-36013/2/2017-Admin dated 23.01.2019; power was delegated to the Chairman, CWC relating to items for the training programs being conducted at NWA, Pune for imparting training to officers/staffs of CWC, State Government and other organization which was subsequently authorized to Chief Engineer, NWA, Pune vide Order No.4/3/2017-O&M/172 dated 28th February 2020.

2. Now in partial modification of CWC office order No.4/3/2017-O&M/172 dated 28th February 2020 it has been decided with the approval of the competent authority to further authorise the powers to Chief Engineer, NWA, CWC Pune as per the following details:



4. The other terms & conditions of the office order No. No.4/3/2017-O&M/172 dated 28th February 2020 will remain the same. This order will be applicable from the date of issue of this office order.
