Subject: Empanelment of CWES (Group A Service) Officers of 1991-1994 batches at Joint Secretary/equivalent level at the Centre-reg.

Sir,

I am directed to refer the subject cited above and to convey in this regard that Department of Personnel & Training (DoPT) has prescribed guidelines for evaluation of officers of Organized Group 'A' Services for empanelment for holding the post of Joint Secretary/equivalent at the Centre, vide their OM No.12/03/2008-EO(SM-III) dated 20th January, 2014.

- 2. The aforesaid OM provides that officers who wish to represent specific concern regarding their performance appraisal over the years which would be relevant for assessing their suitability for empanelment may be permitted to do so at the initial stage itself. This would include issues such as arbitrary down-gradation of the overall grade, mismatch between grading and pen-picture, missing ACRs, assessments recorded for periods less than three months, assessments recorded long after due date etc.
- 3. As a proposal for empanelment of officers at Joint Secretary/equivalent level at Centre is to be submitted to DoPT, it is requested to inform following eligible officers of 1991-1994 batches of CWES about the ensuing empanelment process and seek their representations immediately, in accordance with aforementioned DoPT's OM dated 20.01.2014. The representations received along with comments of CWC may be forwarded to this Department at the earliest.
