
Sealed quotations are invited on behalf of the President of India, by EE, NEID-I, CWC, Silchar from the bonafide and registered contractors/firms to carry out the **'Minor Repair & Maintenance of Type-II (B) and Type II (D) Quarter (in the colony complex & the O/o Executive Engineer) under NEID-I, CWC, Silchar.** The quotation will be received in the office of the undersigned i.e. O/o Executive Engineer, NEID-I, CWC, Rongpur Part-I, Silchar-9 during the working hours up to 15:30 hrs. on or before **26-02-2025** and shall be opened on the same day at 16:00 hours by the undersigned/authorised officials in presence of the interested quotationers or their authorised representatives who desire to remain present at the time of opening of quotations.

Terms & Conditions:

1. The work should be completed as per specification within 30 days from the date of issue of the work order. Failing which appropriate penalty as estimated on the basis of damage suffered due to stated delays Rs- 1000 per day will be levied.
2. The bidder shall submit EMD (Earnest Money Deposit) of Rs. 3,500/- (Rupees Three Thousand Five Hundred only), along with the quotation in the form of Demand Draft/ Treasury challan/call Deposit/ Banker's cheque/ Fixed Deposit receipt drawn on a Scheduled Nationalised Bank in favour of Executive Engineer, NEID-I, CWC, Silchar, payable at SBI, Silchar. Quotations received without EMD will be rejected. MSE & Start-up are exempted from payment of EMD.
3. On acceptance of the quotation, the Firm/Agency shall have to submit Guarantee @ 3% of the tendered amount in the form of an Account Payee D.D/ Fixed Deposit Receipt/ Banker's cheque or Bank Guaranty from any of the commercial bank in favour of Executive Engineer, NEID-1, CWC, Silchar payable at Silchar. This should remain valid for a period of 180 days beyond the date of completion of work.
4. The rate shall be kept valid for minimum period of 60 days from the date of opening of quotation.

5. The rate of GST should be mentioned as applicable.
6. The rate of works should be quoted both in figure and in words.
7. The quotation number with date of its opening has to be clearly mentioned on the top of the quotation and sealed cover Quotation may be dropped in the Tender/Quotation box kept in the office of the undersigned or may be sent by the registered post. (Marked as quotation for Minor Repair & Maintenance of Type-II (B) and Type II (D) Quarter to the undersigned so as to reach on or before the date and time stipulated for receiving the quotation. No quotation will be entertained after the stipulated time.
8. On the behalf of president of India, the undersigned reserves the right to cancel/reject in part or any/all the quotation without assigning any reason thereof and without any financial involvement from either side.
9. Any correction in the quotation should be clearly attested.
10. Request for any advance payment will not be entertained.
11. The work carried out by the firm shall be guaranteed for a period of not less than six months from the date of completion of work.
12. The work should be standard quality and free from all defect and if found not suitable the same shall be asked for replacement at his own cost.
13. All taxes applicable as per rule will be deducted from the final bill.
14. Payment will be made through RTGS on production of bills as per actual.
15. Only those firms having PAN, GSTIN clearance certificate, government registration etc. can be eligible to submit their quotation.
16. Any quotation, which does not comply with the above guidelines, runs the risk of being rejected.
