As per Rule 20 of the CCS(Conduct) Rules,1964, no Govt servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his/her interest in respect of matters pertaining to its service under Government. If anyone throw himself/herself or through their relatives bring political pressure for posting/transfer, disciplinary action will be taken against him/her as per rules.
