## महोदय,

In partial modification to para (1) of OM no. T-97011/1/2022-RMC Dte dated 12.09.2024, approval of competent authority is hereby conveyed to delegate the power of modifications of allocations of funds among various offices under one DDO PFMS code for a particular Object Head in DWRIS Scheme to the concerned Chief Engineer.

The above delegated power can be used in case of requirement of additional funds under a particular Object Head by an office, when funds are available in the same Object Head with any other office under same DDO. In such cases, the respective Chief Engineer of the organization can issue internal modification in budget allocation for that particular Object Head among various offices under that DDO. A copy of such modifications should invariably be forwarded to RMCD and Budget Section, CWC (HQ) for information and record.

In all other cases, which require modification/ updation in PFMS by PAO, CWC (for example changes in allocation either among different Object Heads within the same DDO or in an Object Head among different DDOs), proposals should invariably be forwarded to this office with the approval of concerned Chief Engineer.
