Online applications are invited from the eligible candidates having Degree in Engineering (Civil or Mechanical only) and Degree in non-Engineering discipline for 01-year Apprenticeship Training at Central Water Commission (HQ), New Delhi, Govt. of India under the Apprenticeship Act 1961 and as amended from time to time for the categories/disciplines as follows:

Procedure to Apply:

Please read the general instructions carefully before applying. Candidates must be enrolled on the BOAT's web portal NATS2.0. <https://nats.education.gov.in> and must be verified by the Regional Board. Candidate will need to apply through Establishment (Central Water Commission) user id NDLNDC000048 on the Portal <https://nats.education.gov.in>.

Selection Procedure:

1. A Committee constituted by CWC with the approval of DoWR, RD & GR for the purpose will go through the applications and shortlist the candidates as per the requirement indicated above. Only shortlisted candidates will be informed.
2. Shortlisted Candidate have to produce their original certificates on the date and time which will be communicated by CWC through email.





Important points/ General Conditions

1. The above engagement as Apprentice is purely temporary and does not confer any right/claim whatsoever, either explicitly or implicitly for regular appointment in Central Water Commission (CWC) against any post or otherwise under any legal conditions or precedent. This engagement is valid for a maximum by one year from execution of the contract of Apprenticeship subject to fulfilling of other terms and conditions.
2. **Only fresh pass-out** candidates (who have passed their respective courses in the year 2020 or later) can apply. Candidates who have passed the qualifying examination earlier than 2020 are not eligible. **Candidates with post-graduation degree are not eligible to apply.**
3. Only those candidates who have completed their qualifying examination as regular candidates are eligible to apply.
4. Graduate candidates who had training or job experience for a period of one year or more after attaining the essential qualification are NOT eligible for being engaged as an apprentice under the act.
5. Before applying, the candidates should ensure they fulfill the eligibility criteria and other norms mentioned in the advertisement. Link for Student manual https://nats.education.gov.in/assets/manual/student_manual.pdf may also be visited by applying candidates.
6. Reservation will be applied as per the provisions of the Apprentices Act, 1961 as amended in 1961, 1973 & 2014 and Apprenticeship Rules 1992 as amended from time to time. Applicants belonging to SC (Scheduled Caste)/ST (Schedule Tribe)/ OBC (Other Backward Classes)- Non-Creamy layer, economically weaker section (EWS) and Person with Disability (PWD) shall produce their caste / relevant certificates in prescribed form issued by the competent authority.
7. Reservation for persons with disabilities will be applied in accordance with DoPT's OM No.36035/02/2017-Estt (Res) dated 15th January, 2018 and other relevant orders.
8. Selected candidates must submit the "Medical Fitness Certificate" at the time of joining.
9. The period of training will be 12 months commencing from execution of contract of Apprenticeship.
10. It shall not be obligatory on the part of Central Water Commission, (HQ), New Delhi, where training shall be imparted, to offer any employment to any apprentice after completion of period of his/her apprenticeship training.





11. Suppression of facts will lead to disqualification at any stage.
12. Central Water Commission reserves the right to increase/ decrease the number of seats for apprentice training and to withdraw/cancel the advertisement/selection process if circumstances so warrant without assigning any reason thereof and its decision in this regard will be final.
13. No TA/DA will be paid for Selection Process / Joining, if selected. No claim other than monthly Stipend shall be admissible.
14. The apprentices will not be provided any accommodation/transport by this establishment during the training period.
15. Every apprentice undergoing apprenticeship training is a trainee and not a worker, and as such the provisions of any law with respect to Labour do not apply to or in relation to such apprentices. Only the Apprentices Act 1961 and as amended will apply to or in relation to such Apprentice Trainees.
16. The Apprentice Trainees will have to abide by the terms and conditions of the Contract of Apprenticeship agreed/accepted.
17. 50% of the monthly stipend amount will be paid by CWC and remaining 50% amount will be paid by BoAT Office directly to the account of respective Apprentice after their satisfactory performance.
