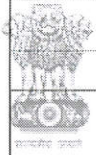
- i) The late bids i.e., the bids received after the specified date and time for receipt of bids shall not be considered.
- ii) The sealed quotation should be super scribed as “Casting & Erection of Damaged & washed out gauge post at site Ashramam under SWRSD-I CWC Trivandrum-reg” and should be addressed to the Executive Engineer, South-western Rivers Division, Central Water Commission, Jaldhara, D.No. 27/1927-A, Kasturba Nagar, P. O. Kadavanthara, Kochi – 682020.
- iii) The quotation must be in the form furnished by procuring entity and should be free from corrections/erasures. In case there is any unavoidable correction it should be properly attested. If not the quotation will not be considered. Quotations written in pencil will not be considered.
- iv) Quotation will be opened on the due date at **11 am** at the indicated venue in the presence of the entities or their representatives who may wish to be present.
- v) The materials /work not conforming to the specifications stipulated above or defective material and substandard works are liable to be rejected any loss or damage that occurred during the transit or rejection of works will have to be borne by the firm itself.
