- The services of the wooden country boat will be in the river Mahananda close to Sonapur Mahananda Bridge.
- The rates are to be quoted both in words and figure against each item. The rates shall be inclusive of all charges.
- The wooden country boating service shall be commenced immediately on receipt of the order for the urgency of
- The boat shall be well equipped with all accessories and appliances as per rules and safety provisions are to be made in the boat against any accident etc. by the supplier at his own initiative and cost. Capacity of boat would be to carry 8(eight) personnel at a time while taking hydrological observation.
