Subject: Amendment to the Government of India (Allocation of Business) Rules, 1961

The undersigned is directed to say that as per the notification dated 31st July, 2014 by the President under clause (3) of article 77 of the Constitution regarding Amendment to the Government of India (Allocation of Business) Rules, 1961, the following changes have been notified :-

(I) In the FIRST SCHEDULE :-

For the heading "41. Ministry of Water Resources (Jal Sansadhan Mantralaya)", the following heading shall be substituted, namely :-

"41. Ministry of Water Resources, River Development and Ganga Rejuvenation (Jal Sansadhan, Nadi Vikas aur Ganga Sanrakshan Mantralaya)."

(II) In the SECOND SCHEDULE :-

(a) For the heading "MINISTRY OF WATER RESOURCES (JAL SANSADHAN MANTRALAYA)", the following heading shall be substituted, namely -

"MINISTRY OF WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (JAL SANSADHAN, NADI VIKAS AUR GANGA SANRAKSHAN MANTRALAYA)"

(b) Under the heading "MINISTRY OF WATER RESOURCES, RIVER DEVELOPMENT AND GANGA REJUVENATION (JAL SANSADHAN, NADI VIKAS AUR GANGA SANRAKSHAN MANTRALAYA)", as so substituted, -

(i) in entry 1, after the words "diverse uses of water" the words "and interlinking of rivers", shall be added;
