

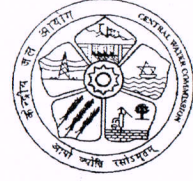

Terms and conditions:

1. The sealed cover containing the quotation should be super scribed as **"White/ Colour Washing of Office Building at Site Kudige"**.
2. The painting materials required for the above works would be supplied departmentally. The petty items such as brushes, rollers, steel blade etc should invariably be brought by the contractor.
