The quotation will be received in the office of the undersigned i.e. NEID-I, CWC, Rongpur Part-I, Silchar-9 during the working hours up to 15.30 hrs. on or before 14/03/2018 and shall be opened on the same day at 16.00 hrs by the undersigned in presence of the interested quotationers or their authorized representatives who desire to remain present at the time of opening of quotations.

Terms and Conditions :-

1. The works should be completed as per specification within 07 (Seven) days from the date of issue of the work order. All the digitized drawings/maps should be AUTOCAD (2010 to latest version) compatible. Soft copy of aforesaid final maps/drawings should be submitted in a compact disc.
2. The work should be standard quality and free from all defects and if found not suitable the same shall be asked for replacement at his own cost.
3. The rates shall be kept valid for minimum period of 60 days from the date of opening of quotation.
4. The rates are to be quoted F.O.R. destination inclusive of packing forwarding, freight, insurance, if any, at the office of the Executive Engineer, NEID-I, CWC, Rongpur Part-I, Silchar.
5. The rates should be inclusive of all local taxes such as Service Tax/GST etc.
6. Rates of Service tax/GST should be mentioned as applicable.

7. The rate of works should be quoted both in figures as well as in words.
8. The quotation number with date of its opening has to be clearly mentioned on the top of the quotation and sealed cover.
9. Quotation may be dropped in the Tender/Quotation box kept in the office of the undersigned or may be sent by the registered post/speed post. (Marked as quotation for Digitization of topographical maps/drawings (23 nos.) of various scales of Sonai and Umsiang irrigation projects) to the undersigned so as to reach on or before the date and time stipulated for receiving the quotation. No quotation will be entertained after the stipulated time.
10. The quantities mentioned are likely to increase or decrease at the time of placing of supply/work order.
11. Any correction in the quotation should be clearly attested.
12. Request for any advance payment will not be entertained.
13. All taxes applicable as per rule will be deducted from the final bill.
14. The work carried out by the firm shall be guaranteed for a period of not less than six months from the date of completion of work.
15. The undersigned reserves the right to cancel/reject in part or full or any/all the quotation without assigning any reason thereof and without any financial involvement from either side.
16. Payment will generally be made on A/C Payee's Cheque drawn on SBI, Silchar on production of bills as per and if payment is to be made by Demand Draft, the bank charges will be deducted.
17. Name & address of A/c payee to whom tax deducted at source may be paid shall be mentioned alongwith the bill.
18. Only those firms having PAN/GSTIN clearance certificate etc. can be eligible to submit their quotation.
19. Any quotation, which does not comply with the above guidelines, runs the risk of being rejected.
20. In case of any dispute, the decision of The Executive Engineer, NEID-I, CWC, Silchar-9 shall be final and binding on all concerned.
