TERMS AND CONDITIONS:

- The quotation should be submitted in the sealed cover. The sealed cover should be super scribed "quotation for Drilling of Borewell at CWC Office Premises "KG Bhavan", A.C Guards, Hyderabad-4." due for opening on 15.03.2018 at 1500 hrs. This sealed Tender should be addressed to the Executive Engineer, Lower Krishna Division, CWC, "K.G. Bhawan" H.No. 11-4-648, Room No.413, A.C Guards, Hyderabad -500 004 (TS) and reach this office on or before 15.03.2018 by 1400 hrs. The quotation received after the due date and time will be summarily rejected. The quotation received will be opened on the same day i.e. on 15.03.2018 at 1500 hrs in the presence of Bidders or their representatives if present.
- The quotation document can be obtained from C.P.P. Portal of Govt. of India & website of CWC i.e. www.cwc.gov.in.
- The rates/amount must be inclusive of all statutory liabilities & other charges but excluding GST. The amount must be indicated in figures and in words. Corrections & over writings shall be duly attested by the bidder, failing which the tender(s) shall not be accepted.

4. The bidders are required to submit the attested copies of valid Registration of Firms, PAN Card and upto date GST & Service Tax clearance/Income tax returns for the last one year, bank A/c statement of last one year, along with the bid documents, failing which the tender shall be declared as non-responsive and thus liable for rejection.
5. **Bid validity:** Bid shall remain valid for the period of 60 days from the date of bid opening. The work should be completed within 10 days from the issue of work order. Exceptional circumstances, time limit for completion of work can be extended, for which the bidder has to give in writing stating the circumstance under which the time limit for completion of work is requested.
6. The right to reject any quotation or all the quotations, without assigning any reason thereof, rests with the undersigned.
7. **Award criteria:** The work shall be awarded to the Bidder whose Bid has been found to be substantially responsive and who has offered the lowest evaluated Bid Price.
8. **Notification of Award:** The bidder whose bid has been accepted will be notified of the award by this office prior to expiration of the Bid validity period. This letter of acceptance will state the sum that the employer will pay the contractor in consideration of the execution of the works by the contractor.
9. **Dispute Resolution Mechanism:** Any disputes arising on the contract, the decision of the undersigned will be final and binding to the bidder.
10. **Payment Terms:** No intermediate payment shall be made for work. The payment will be released to the Firm/contractor by the Executive Engineer after completion of work in all respect/. For which the Firm/Contractor has to submit the Bill in triplicate. Taxes as applicable will be deducted from the bill.
11. **Labour Laws to be complied:** The contractor shall comply with the provisions of the relevant central and state labour laws.
12. **Other terms and conditions:**
 - i) The Department will not be responsible for any injury sustained to the Firm/Agency workers during the performance of their duties and also for any damage or compensation due to any dispute between the Agency and its workers. Any expenditure incurred by the department to face the situation arising out of act of his workers will be made good by the agency. If any incident happens during the duty period the department will not be held responsible for the same. It is the responsibility of the firm / agency to provide sufficient insurance coverage /compensation as per the latest act in force.
 - ii) The Firm/Agency shall work as per the instructions of the EXECUTIVE ENGINEER, LOWER KRISHNA DIVISION, and CWC, HYDERBAD or his authorized representative.
 - iii) Interested bidders can visit the work site any of the week days (except 2nd Saturday & Sunday) during office hours before quoting their rates.
