- (5) Any corrections cuttings in the quotation document shall be initialed by the bidder.
- (6) The work shall be executed as per the approved specifications and CPWD norms.
- (7) Quotation shall remain valid for the period of 30 days from the date of opening of quotation.
- (8) All materials required for the work are to be supplied by the contractor. The material must be of standard quality and as per specifications and free from all defects. The material if found defective subsequently or not conforming to the specifications as stated above, have to be replaced by the firm without any additional charges.

- (10) The dismantled debris should be disposed off by the contractor after completion of the work in full shape.
- (11) The work shall be completed in all respects within 7 days from the date of issue of the work order.
