The Executive Engineer, L.B. Late bids after specified date & time shall not be considered. Intending bidders may present at the time of opening of auction bid.
- 2. The listed materials will be available for inspection "As is where is Basis" and the interested parties can inspect listed materials during any working days between 15:00 Hrs to 17:00 Hrs up to **08.02.2018** In the respective office premises as mentioned in enclosed Annexure under the office of the Executive Engineer, L.B.Division, CWC, Jalpaiguri.
- 3. Every bidder has to attach with bid of earnest money amounting to Rs. 1577/-(Rupees One thousand seven hundred seven only) in the form of cash/Demand Draft/FDR/TC/Pay Order in the favour of the Executive Engineer, L.B.Division, CWC, Jalpaiguri. The cash should be deposited to the cashier of L.B.Division, CWC, Jalpaiguri and the copy of money receipt should be attached along with the quotation.
- 4. The bids received without earnest money shall be treated as invalid and shall be disqualified.
- 5. The earnest money will be refunded back to all the bidders except the highest bidder after completion of the auction. The successful bidder will have to deposit full amount of bid within 24 hours of the receipt of notice of the acceptance of the bid. The successful bidder has to lift/remove the materials from the office premises within 03 days from the date of acceptance of bid.
