

ELIGIBILITY OF THE BIDDER:

- 1. The Firm should have been registered under company act and in the business of Providing Aerial surveys, 3D Photogrammetry, digital mapping, 3D visualization and allied works in India for last 5 years or more from the date of opening of the tender.
- 2. Firm should have done at least ten (10) projects with government /PSU by UAV monitoring / survey.
- 3. Firm should have the ability to carry out 3D Photogrammetry processing from the UAV images and should have work on at least 1 similar project using drone in highly hilly terrain with government /PSU.
- 4. Firm should have stereo Photogrammetry workstation with professional photogrammetry software and hardware such as 3D glasses, Stealth 3D Mouse, 3D monitors for processing of the data and demonstration of final output to client.
