**Terms & Conditions**

1. Interested parties may submit their highest price for vehicle in the prescribed proforma (Annexure-II) of quotation document in a sealed cover clearly superscribing as 'Quotation for disposal of old condemned AMBASSADOR CAR (petrol) No.KA-01N-9604' to be opened on 12/03/2018 at 4.00 PM by Superintending Engineer(Coord.), Office of the Chief Engineer, Monitoring South Organization, Jalasoudha, Jalahalli Post, Bengaluru-560013. Unsealed and Unsigned quotations will be summarily rejected.
2. The quotation should reach this office latest by 3.00PM on 12/03/2018. The same will be opened on the same date at 4.00PM. Quotation should be dropped in the Quotation box kept outside the chamber of Junior Engineer (HQ), 1<sup>st</sup> floor, Monitoring South Organization, Jalasoudha, Jalahalli Post, Bengaluru-560013. The bidder or their authorized representative (not more than one) may witness the quotation opening, at the time of opening the quotation.
3. The car has been kept in the premises of Monitoring South Organization, Jalasoudha, Jalahalli Post, Bengaluru-560013(ground floor car garage). The intended bidders may inspect the vehicle on any working day between 3.00 PM to 4.00 PM from 05.03.2018 to 09.03.2018 (Tel: 29724081, 8884547577).
4. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this Office.
5. Earnest money deposit **(EMD) of Rs.1000/- (Rupees One Thousand only)** in the form of DD/Banker's cheque in favor of Executive Engineer, Cauvery Division, Bengaluru payable at Bengaluru should accompany each quotation, without which the quotation will not be considered.
6. The successful bidder accepted by the competent authority has to pay 10% of the bid amount as a security deposit. The EMD submitted with quotation document will automatically be converted into a part of Security deposit and balance, if any, has to be paid to CWC, by cash/banker's cheque/DD in favour of Executive Engineer, Cauvery Division, Bengaluru payable at Bengaluru within 7(Seven) days from the date of communication about the acceptance of the quotation. If the EMD paid is in excess of Security deposit it will be with CWC as part of bid amount.

The balance bid amount has to be paid to CWC by cash/banker's cheque/DD in favour of Executive Engineer, Cauvery Division, Bengaluru payable at Bengaluru within 07 (seven) days from the date of communication about the acceptance of the quotation, failing which the earnest money and security deposit shall be forfeited.

9. The EMD of the unsuccessful bidder shall be refunded within a month from the acceptance of quotation.
10. All, writings/quotes should be clear and legible and cuttings/corrections if any, in the quotation should be attested by the bidder, otherwise it will make them liable to disqualification and rejection.
11. No representation for enhancement of dates on the opening of quotations will be acceptable.
12. No telegraphic quotations/bids are acceptable.
13. Taxes as applicable at the time of delivery will have to be paid extra on the total amount quoted by the successful bidder.
