4.	What document should be submitted for clean record? Whether undertaking is required on stamp paper or letter head?	It was clarified that Undertaking is to be submitted by firm on letter head only.
5.	Minimum how many number of tenders are required.	Minimum 3 numbers of tenders are required.
6.	What is meaning of requirements of equipments?	It was clarified that observation equipments provided by purchaser and safety equipments shall be provided by tendered firm.
