- 1. The bids should be submitted in sealed cover/Envelope super-scribed "Bids for Disposal of old & unserviceable T&P articles of Mahi Division due on 05.12.2016 time 3.00 PM".
- 2. The sealed bids should be dropped in the tender box placed in the office of the Executive Engineer, Mahi Division, CWC, 3<sup>rd</sup> Floor, Narmada Tapi Bhawan, Sector-10A, Gandhinagar on or before 05.12.2016 by 3.00 PM and will be opened on the same day at 3.30 PM in the office of the Executive Engineer, Mahi Division, CWC, 3<sup>rd</sup> Floor, Narmada Tapi Bhawan, Sector-10A, Gandhinagar. Intending bidders may be present at the time of opening of Bids.
- 3. The rates/ amount shall be quoted in figures & words separately for each item/ lot as mentioned in Annexure -I. **Bids will be evaluated on consolidated rates**. Item wise evaluation will not be done. Taxes & other levies, freight if any, will have to be borne by the bidder.
- 4. CWC will not entertain any claim for damage done by way of theft, pilferage, fire or any other unforeseen calamity after realizing full payment against the sale of unserviceable items.
- 5. Every bidder has to deposit Earnest Money Deposit (EMD) in cash/ Demand Draft in favour of EE, MD Gandhinagar amounting to Rs 300/- (Rupees Three hundred only), The cash should be deposited to the to the cashier of Mahi Division, CWC, Gandhinagar and the copy of the money receipt should be attached along with the quotation. In case of DD the DD should be attach with the quotation.
- 6. The bids received without EMD shall be treated as invalid & shall be disqualified.
- 7. The auctioned items are to be lifted within 5 days of the issue of letter of offer on making full payment thereof; otherwise the earnest money deposited shall be forfeited.
