Notice Inviting Tender

Sealed tenders are invited on behalf of President of India by this office for following work from the reputed contractors as per details, terms and conditions given below. The tender should reach this office latest by 15.00 hours on 04.04.2015 and the same will be opened on the same day at 15.30 hours in presence of the bidders or representative thereof, if any.

Terms and Conditions:-

1. The sealed cover should be super scribed with words “**Tender for Providing Partition wall with Laminated Board and glass with Aluminum frame in the Technical Section (Drawing Branch) at SWRD, Cochin & Date of opening 04.04.2015**” and should be addressed to the Executive Engineer, SWRD, CWC, Cochin.
2. The bidders should submit tender with their rates on the blank spaces provided in the tender along with their letter pad if any and should sign the tender with their firm seal accepting the terms & conditions. The tender in any other form may likely to be rejected.
3. Bidders must have PAN/TIN/Service Tax number.
4. The rates quoted shall be inclusive of all the duties/ taxes and service tax.
5. The quoted rates should remain valid for 90 days from the date of opening of the tenders.
6. Tenders erased and over written will be summarily rejected unless corrections are authenticated with bidder's signature.
7. The work should be completed within 10 days of the issue of confirm order.
8. The work should be of good quality and free from defect and if found not suitable the same should be replaced by the contractors at his own cost & risk.
9. The quantity will be decreased or increased at the time of work order for which the contractor should bind to execute the works.

10. The materials should be of good quality and free from defect and if found not suitable the same should be replaced by the contractor at his own cost & risk. Before starting the work, material shall be got approved from Assistant Director-II/Junior Engineer(Tech), SWRD, CWC, Cochin.
11. Damage to the building during execution of work shall be made good by the contractor matching with the surrounding surface, otherwise the same shall be got done at the cost of working contractor.
12. Any damage to the existing fittings shall be replaced by the contractor at his own cost and risk to the entire satisfaction of Engineer-in-charge.
13. The department will not be responsible for any injury sustained to the workers during the performance of their duties on the work and also department will have no obligation to workers for any damage or compensation due to any disputes between the Contractor and the workers.
14. Canvassing in any form whether directly or indirectly is strictly prohibited.
15. Intending Tenderers are advised to inspect and examine the areas and its surroundings and satisfy themselves before submitting their tenders. A tenderer shall be deemed to have full knowledge of the area whether inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed.
16. The tenderer shall be responsible for arranging and maintaining at his cost all materials, tools & plants, fuel & lubricants and all other services required for executing the work unless otherwise specifically provided for in the contract documents.
17. In case of any disputes arises, the decision of the undersigned is final and the Contractor will be binded for it.
18. The information of unsuccessful tenders will not be given to concerned bidders and bidders shall have no claim of any nature on this office.
19. In case of any litigation due to accident, the contractor shall handle at its own cost and in the event of the department happens to be incurred any expenditure towards litigation, the same shall be recovered from the contractor. In case of any dispute, the decision of the "Undersigned" will be final and binding.
20. The "contractor" shall work under the control of the "Undersigned" or his authorized representative.
21. Contractor shall be responsible for the conduct, behaviour and fidelity of the persons employed for the work.
22. Any person of contractor is found in drunken state or found misbehaving while on work or unfit for work; such personnel shall be replaced immediately at the absolute discretion of "Undersigned" or his representative.
23. Payments will be made by A/C payee Cheque payable at SBI, Kochi after completion of satisfactory work, for which a pre-receipted bill in triplicate should be submitted after completion of work. No advance payment shall be made.
24. The payment will be made on the basis of actual measurement.
25. Income tax @ 2% of the total value of work will be deducted from the bill.
26. For any breach of conditions mentioned above, the "Undersigned" shall have absolute power to withhold such amount from the claim of the "contractor", which he finds suitable to compensate damages/risk caused by negligence of its personnel.
27. **The offer shall be accompanied with Earnest Money Deposit (EMD) of Rs. 1600.00 (Rupees One Thousand Six Hundred only) in the form of an Account Payee D.D/Fixed Deposit Receipt/Banker's Cheque from any of the scheduled bank guaranteed by Reserve Bank of India in favour of Executive Engineer, SWRD, CWC, payable at Cochin or by cash with the cashier of this office. This should remain valid upto 60 days from the date of opening for acceptance of the tender. For unsuccessful tenders EMD shall be refunded immediately. In case of non submission of EMD, the offer will be liable for rejection.**

28. Earnest Money Deposit (EMD) shall be forfeited, if successful bidder withdraws his offer before the expiry of the validity period or fails to complete the work within the stipulated period from the date of order.
29. **The whole work shall be guaranteed for a period of 6 (six) months from the date of actual completion as recorded.** The work should be completed satisfactorily and in all respect as directed by this office. In the event of any defect is found within the guaranteed period due to faulty design or bad workmanship, the whole work or a part will be replaced by the "Contractor" at site free of cost within 5 days of intimation.
30. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of the terms and conditions.
31. Any other rules & codes of CPWD and its amendment as applicable will be binding on the successful bidder for this deal.
