- iii) I also undertake to produce a 'No Demand Certificate' from all concerned before I am allowed to proceed abroad on leave.
- iv) I undertake not to approach any foreign agency for financial assistance without prior approval of Government of India.
- v) I undertake not to enter into any kind of correspondence with any foreign agency except through CWC.
- vi) I undertake not to take any employment whatsoever while abroad including from any foreign employer.
- vii) I understand that a grant of permission by itself does not involve any commitment on the part of the Govt. of India to release any foreign exchange to me and I will have to make my own arrangements for foreign exchange required for the visit, if any.
- iii) I also understand that the grant of No Objection Certificate will be subject to any general or specific conditions that the Govt. of India may impose from time to time.
- ix) I also understand that the grant of leave for which I will apply in due course will be subject to the exigencies of office work, and request from me for grant of extension of leave while abroad beyond the period initially applied for and sanctioned will not be entertained under any circumstances.
- x) I however understand that no payment of leave salary will be made to mein foreign exchange.
- xi) I undertake not to take part in any activity while abroad which would contravene the provisions of CCS Conduct Rules 1964 as amended from time to time.
