## **CIRCULAR**

Subject:

52<sup>nd</sup> Departmental Examination for Engineering Officers of Central Water Commission.

It is proposed to hold the 52<sup>nd</sup> Departmental Examination for Engineering Officers of the Central Water Commission in the month of <u>December, 2017</u>. The Centre for the examination will be <u>Delhi</u> and/or <u>Pune</u>. Candidates may, therefore, give their option for the centre nearest to their working place in the application form. However, in case sufficient applications are received from a particular region, the centre may also be fixed in the nearby city. The same would be considered, but the final allotment of centre would be subject to number of options received and administrative feasibility. The final venue will be intimated in due course alongwith Roll Numbers of the individual candiates.

- 2. As per the Central Water Engineering (Group-A) Service Rules, officers in the grade of Assistant Director/Assistant Executive Engineer are not eligible for promotion to the grade of Deputy Director/EE unless they qualify the examination within four years of their regular appointment to the grade of AD/AEE and not exceeding four appearances/chances.
- 3. Detailed Rules and Syllabus for the Departmental Examination for Engineering Officers of Central Water Commission are available on the website of CWC at <a href="http://www.cwc.nic.in/main/webpages/publications.html">http://www.cwc.nic.in/main/webpages/publications.html</a>. The Rules and Syllabus for the Departmental Examination have been revised in June 2014 in consultation/approval of the Ministry of Water Resources, RD & GR with substantial changes in the old Rules and Syllabus. Hence, the candidates are strongly advised to go through the rules and syllabus carefully.
- 4. In case officers in the grade of AD/AEE fail to fulfil the provisions laid down in para 2 above, they would no longer be eligible to appear at this or in any subsequent departmental examination. Such officers will have to apply, separately for extension of time through proper channel. As per Rule 2(d) of Rules for Departmental Examination for Engineering Officers of CWC, if extension of time is sought on the ground of exigencies of service, the Director/SE concerned shall recommend the same. In case extension of time is sought on medical grounds, it should be supported by a proper Medical certificate. However, the decision of competent authority whether to grant extension or not shall be final.

5. The previous syllabus included five papers viz. (1) Professional paper I (separate for Civil and Mechanical Engineers); (2) Professional paper II (separate for Civil and Mechanical Engineers); (3) Professional paper III (separate for Civil and Mechanical Engineers); (4) Accounts Paper (same for both Civil and Mechanical Engineers); and (5) Viva-voce Test.

The **new syllabus**, however, has four papers; namely **(1) Professional Paper I** (Section A is common for both Civil and Mechanical Engineers, Section B for Civil Engineers and Section C for Mechanical Engineers); **(2) Professional Paper II** (Section A is Common for both Civil and Mechanical Engineers, Section B for Civil Engineers and Section C is for Mechanical Engineers); **(3) Professional Paper-III** is Common for both Civil and Mechanical Engineers and includes subjects viz. Accounts, Administrative Matters, Disciplinary and vigilance matters, RTI, Budget and Procurement etc.; and **(4) Viva-Voce**. 6. Candidates who have appeared in earlier departmental examinations and could not qualify one or more than one paper, they would be required to qualify the papers as per new syllabus in the following manner:

- 7. Since Assistant Directors/AEEs have to qualify the Departmental Examination in specified four attempts and within given period of 4 years, they will be entitled to draw TA/DA for appearing in the examination under SR 130 and their absence from duty will be regulated under provisions of the Government of India Order No. 5 below FR9(6)(b).
- 8. Officers in the grade of AD-II/AE are eligible to appear in the Departmental examination and if they qualify the examination they will not be required to pass the same after promotion to the grade of AD/AEE. The limitation of four years will not, however, apply in their case so long as they serve in the grade of AD-II/AE.
- 9. The candidates have the option to write answers either in English or in Hindi.

- 10. Application complete in all respects may be sent in the prescribed proforma (enclosed), through proper channel, to Estt.I Section, CWC, New Delhi duly approved at the level of Director/SE concerned **ON OR BEFORE 10.11.2017**. Applications received beyond the stipulated date would outrightly be rejected. Candidates are requested to fill up all the columns properly, failing which the application is liable to be rejected.
