



Inconsistent with the bidding documents, the Employer's rights or the bidder's obligations under the contract, or who's Rectification would affect unfairly the competitive position of other bidders presenting substantially responsive bids. If a bid is not substantially responsive, it will be rejected by the Employer and may not subsequently be made responsive by correction or withdrawal and the non-confirming deviations or reservations.

- 34. **Award criteria:** The employer shall award the supply to the Bidder whose Bid has been found to be substantially responsive and who has offered the lowest evaluated Bid Price.
- 35. **Signing of Contract:** The successful bidder, on acceptance of his bid by the Accepting Authority, shall execute the Contract in the agreement form.
- 36. Changes in Contractor's organization to be approved: When the contractor has enter into a Partnership with an individual or firm after submission of bids, approval in writing of the Employer shall be obtained before any change is made in the constitution of the firm. If previous approval from the employer is not obtained, action may be taken against the contractor as per relevant rules in force.
- 37. **Payment Terms:** No advance or intermediate payment would be made. - 38. The firm should submit bill (in triplicate) along with an advance stamped receipt immediately after supply of the instrument in full for making payment.
- 39. Taxes as applicable will be deducted from payments made to Tenderer at the prescribed rate by Govt. of India.
- 40. Service Manual: Service manual with circuit diagram will have to be provided with the instrument.
- 41. **Repair & Maintenance:** The tenderer should furnish the detailed data for repair and maintenance facilities as would be extended by them, in case of necessity.
- 42. **Termination of Contract:** Without prejudice to any of the rights or remedies under this contract in case of Contractor absconding or demise, the Executive Engineer on behalf of the President of India shall have the option of terminating the contract without compensation to the Bidder

# STEEL BOAT (5.5 m)

### Purpose

The steel boat will be used to execute hydrological measurements in rivers, canals and reservoirs. Many of the measurements will be made in very shallow water.

# **Conditions & Requirements**

- The boat shall be of such a design that it operates reliably and safely under the prevailing environmental and hydraulic conditions.
- The boat shall be capable to operate in shallow water where repeatedly the hull may impact with rock or sediment.

- The outboard engines shall be operated by a remote control system, located at the side bulkhead of the cabin.
- The control system shall match the outboard engines.
- A break water arrangement shall be provided in the front.
- Guard-rail and stanchions with detachable chain will be rigged out around the deck opening. Suitable guard-rails shall also be provided around the deck.
- Bollards and fairleads are to be provided on the deck for mooring purpose.
- A maintenance manual, related to the type and model of the boat, shall be part of the delivery.
