"SUMMARY RECORD OF DISCUSSIONS OF THE 111th MEETING OF THE ADVISORY COMMITTEE ON IRRIGATION, FLOOD CONTROL AND MULTI PURPOSE PROJECTS, HELD ON 17th AUGUST 2011 FOR CONSIDERATION OF TECHNO-ECONOMIC VIABILITY OF PROJECT PROPOSALS."

The 111th meeting of the *"Advisory Committee on Irrigation, Flood Control and Multi-purpose Project"* was held on 17.08.2011 at 1000 hrs. in the Conference Room of Central Water Commission, Sewa Bhawan, R.K. Puram, New Delhi under the Chairmanship of Shri D.V. Singh, Secretary (WR). List of participants is enclosed at Annexure-I.

At the outset, Chairman welcomed the participants and requested the Member-Secretary to take up the agenda for discussion. Agenda items discussed and decisions taken are as under:

I) CONFIRMATION OF THE SUMMARY RECORD OF THE DISCUSSIONS HELD DURING THE 109TH MEETING:

The Summary Record of Discussions of the 110th Advisory Committee meeting was circulated vide Letter No.16/27/2011-PA (N)/1391-1424 dated 05.08.2011. Since, no comments on the same have been received, the Committee confirmed the Summary Record of discussions of the 110th Advisory Committee meeting.

II) PROJECT PROPOSAL CONSIDERED BY THE ADVISORY COMMITTEE:

- 1) Flood Protection and Training works on Phyang Nallah (Estimated Cost-Rs.58.57 crore at 2010-11 Price Level)
- 2) Flood Protection and Training works on Igoo Nala (Estimated Cost-Rs.35.83 crore at 2010-11 Price Level)
- 3) Flood Protection and Training works on Saboo Nallah (Estimated Cost-Rs.47.04 crore at 2010-11 Price Level)
- 4) Flood Protection and Training works on Ney Basco Nallah (Estimated Cost-Rs.59.41 crore at 2010-11 Price Level)
- 5) Flood Protection and Training works on Nimoo Nallah (Estimated Cost-Rs.26.25 crore at 2010-11 Price Level)

All the above five project proposals are having similar features. On a query regarding basis for computation of crop damage and completion of the projects by March 2013, representatives of the Government of Jammu & Kashmir explained that keeping in view of the extreme weather conditions in Leh region the one year data for crop damage was possible and the works would be executed by a full fledged agency having rich experience of such type of works. There would be no delay in execution of works provided the funds are released in time.

After brief discussion, the Committee accepted the proposals.

- 6) **MITIGATION OF FLOODS IN ONATTUKARA REGION COMPRISING OF 12 WATERSHEDS IN KERLA STATE. (Estimated Cost-Rs.248.39 at 2010 Price Level).**

The representative of the Government of Karnataka stated that this project is a part of Prime Minister's Kuttanad Package. Planning Commission representative clarified that in case of spilling over the works from XI plan to XII Plan; fund earmarked for this package would also be available in the XII Plan. Regarding target date of completion of the project, Project Authorities confirmed that the work on the project would be started as soon as investment clearance is accorded and funds are made available to the project. They also confirmed that the works would be completed within the stipulated target of December, 2012 provided requisite funds are made available in time. The detailed benefits to be accrued from the project were also explained.

After brief discussion, the Committee accepted the proposals.

- 7) **FLOOD PROTECTION WORKS FOR RIVER BANKS OF KABINI AT SUTTUR MUTT TOWNSHIP, NANJANGUD TALUK OF MYSORE DISTRICT, KARNATAKA. (Estimated Cost-Rs.26.93 crore at 2010-11 Price Level).**

On a query regarding target date of completion of the project, Project Authorities explained that the work on the project would start as soon as investment clearance is accorded to this project and would be completed by the stipulated target i. e. by March, 2012. The detailed break-up of the benefits to be accrued from the project was also explained.

After brief discussion, the Committee accepted the proposal.

- 8) PROTECTION OF BISWANTH PANPUR INCLUDING AREAS OF UPSTREAM SILAMARI AND FAR DOWNSTREAM BHUMURAGURI TO BOREGAON AGAINST EROSION OF THE RIVER BRAHMPUTRA. (ESTIMATED COST-RS.167.09 CRORE AT 2010-11 PRICE LEVEL).

It was informed that the project proposal was considered in the 110th meeting of the Advisory Committee but was deferred for want of the recommendation of the State Technical Advisory committee and the State Finance concurrence. Member-Secretary informed that these have now been received. The Committee accepted the proposal.
