SUMMARY RECORD OF DISCUSSIONS OF THE 114th MEETING OF THE ADVISORY COMMITTEE ON IRRIGATION, FLOOD CONTROL AND MULTI PURPOSE PROJECTS, HELD ON 28th MARCH 2012 FOR CONSIDERATION OF TECHNO-ECONOMIC VIABILITY OF PROJECT PROPOSALS

The 114th meeting of the "Advisory Committee on Irrigation, Flood Control and Multi-purpose Project" was held on 28th March 2012 at 1600 hrs. in the Committee Room of Ministry of Water Resources, Shram Shakti Bhawan, New Delhi under the Chairmanship of Shri D.V. Singh, Secretary (WR). List of participants is enclosed at Annexure-I.

At the outset, Chairman welcomed the participants and requested the Member-Secretary to take up the agenda for discussion. Thereafter the Agenda items were taken up for discussion and the decisions taken are as under:

I) CONFIRMATION OF THE SUMMARY RECORD OF THE DISCUSSIONS HELD DURING THE 113TH MEETING:

The Summary Record of Discussions of the 113th meeting of the Advisory Committee was circulated vide Letter No.16/27/2011-PA (N)/205-35 dated 02.02.2012. Since no comments on the same have been received, the Committee confirmed the Summary Record of discussions of the 113th meeting of the Advisory Committee.

II) PROJECT PROPOSALS CONSIDERED BY THE ADVISORY COMMITTEE:

- 1.0 Raising and Strengthening of Adhwara and Khirol left Embankment from RD 0.0 km to RD 43.60 km & from RD 44.00 km to RD 90.50 km and right Embankment from RD 0.0 km to RD 81.50km in Sitamarhi, Madhubani and Darbhanga districts of Bihar (Estimated Cost Rs. 167.03 Crore at 2011 Price Level):

02/04/12* The representative of Government of Bihar intimated that the project would be completed within the scheduled time frame i.e. by the year 2012-13. Regarding query about pitching of embankment (on the river side) the state government representative clarified that the same would not be required in this particular case since the embankment has been provided at suitable distance from the main course of river. The

state representative also agreed that model test would be ensured for firming up the configurations and levels before execution of work.

After brief discussions the committee accepted the proposal.

2.0 Improvement of Emabankment and Ancillary Works in Kandi and other Adjoining Areas of District of Murshidabad of West Bengal (Estimated Cost Rs. 438.94 Crore at 2011 Price Level):

The representative of Government of West Bengal intimated that the proposed project will provide relief to the people in the chronically flood prone Kandi area in the state. Regarding query about low B.C. Ratio, the state representative explained that the proposal covers the region affected due to three streams and embankments are required to be provided along these three streams for protection. In reply to query about designs of the project components, the state representative clarified that the design parameters would be ascertained through model studies before execution of the project. They also mentioned that phasing has been done in realistic manner and hence, the project will be completed by the scheduled time i.e. within the period of five years.

After the brief discussions the committee accepted the proposal.

3.0 Revised scheme for construction of Mahadewa –Uska embankment along right bank of river Kunra in Siddharthnagar district of Uttar Pradesh (Estimated Cost Rs. 27.76 Crore at 2008-09 Price Level) and

4.0 Revised scheme for construction of Balrampur-Bhadaria embankment along right bank of river Rapti in Balrampur district of Uttar Pradesh (Estimated Cost Rs. 25.61 Crore at 2008-09 Price Level):

04/04/12 The representative of Government of Uttar Pradesh informed that works on the above projects are going on under FMP Programme and extended works shall be completed using state plan fund. Regarding query about completion of the project at the estimated cost based on 2008-09 price level, the state representative clarified that all the works have already been awarded and the contractors have agreed to complete the work at the same price level.

After the brief discussions, the committee accepted both the proposals subject to receipt of State Finance Concurrence.

The meeting ended with a vote of thanks to the Chair.
