Background:

1. *RTI applications with Registration Nos. CWCND/R/T/24/00111 dated 06/06/2024 and CWCND/R/T/24/00110 dated 05/06/2024 were received in the office of Director (WP&P-Cord.) & CPIO, WP&P Wing on transfer from Department of Water Resources, River Development & Ganga Rejuvenation, on 06/06/2024 and 05/06/2024 respectively. Both RTI applications mention about earlier RTI application with registration no. CWCND/R/E/24/00020 dated 17/01/2024 for which information was provided by CPIO, WP&P vide his letter dated 06.02.2024. The RTI application dated 05.06.2024 and 06.06.2024 were also replied by CPIO vide his letter dated 14.06.2024 against which the two appeals have been filed by the applicant.*
2. *The information sought in the RTI Applications dated 17.01.2024 were as under:*
 - i. *Information regarding Telangana CM appeals to the Union Ministry to consider National Projects Status for Palamuru Rangareddy Lift Irrigation Scheme of the State of Telangana during the recent visit to New Delhi in the start of January 2024.*
 - ii. *Information regarding Union Ministry's response on above*
 - iii. *Information regarding practice of granting National Project Status stopped to eligible irrigation projects of the country as per newspaper published news in this regard.*

CPIO, WP&P Wing provided the information to the applicant vide letter dated 06/02/2024

3. *The information sought in the RTI Applications dated 05/06/24 & 06/06/24 were as under:*

- i. *Final view taken by the department in connection with the Declaration of Palamuru Rangareddy Lift Irrigation Scheme(PRLIS) of Telangana as a National Project in connection with the appeal made by the Telangana Chief Minister (CM) to the Union Ministry to consider National Project Status for Palamuru Rangareddy Lift Irrigation Scheme (PRLIS) of State of Telangana during the recent visit to the New Delhi in the start of January 2024.*
- ii. *Decision taken by the Union Government declaring Palamuru Rangareddy Lift Irrigation Scheme (PRLIS) of the State of Telangana.*

CPIO, WP&P Wing provided the information to the applicant vide letter 14/06/2024

However, applicant has preferred appeals on grounds "Provided Incomplete, Misleading or False Information" / Any Other Ground.

Decision:

I got relevant records in WP&P wing examined and found that in the light of appeal made by Hon'ble Chief Minister of Telangana regarding declaration of Palamuru Rangareddy Lift Irrigation Scheme(PRLIS) of Telangana as a National Project, final view taken by DoWR, RD & GR is not available in WP&P wing. It is further stated that inputs of CWC on the VIP reference of Shri A. Revanth Reddy, Hon'ble Chief Minister of State of Telangana received in CWC on 11/01/2024 which was regarding Declaration of Palamuru Rangareddy Lift Irrigation Scheme (PRLIS) as National Project, was provided to SPR wing of MoWR. The same was also communicated to applicant by CPIO vide his letter dated 06.02.2024 while replying to applicant's RTI application dated 17.01.2024. Also, while replying to the RTI applications dated 05.06.2024 and 06.06.2024, CPIO vide his letter dated 14.06.2024, has also requested Deputy Commissioner & CPIO, SPR-I, MoJS (dcspr-mowr@gov.in) to provide updated information from SPR wing of the Ministry to the applicant.

In the view of above, the RTI Appeal Nos. CWCND/A/E/24/00033 dt 14-06-2024 & CWCND/A/E/24/00034 dt: 14/06/2024 filed by Shri Ramesh Chandra Varma is disposed off.
