3. The work should be completed within one month of work order placed. No time extension will be given for completion of the work until and unless beyond the control of human beings.
4. Rates should be mentioned, inclusive of all taxes, levies, transportation, loading, unloading and stacking of materials and providing necessary labour, materials, equipments
5. The rates quoted should be valid at least for a period of six months from the date of opening of the quotation.
6. No T&P materials for any work including scaffolding/shuttering, will be provided by this department for the above work.
7. The department will not arrange any Geologist and it is the sole responsibility of the quotationer to get geophysical investigation done.
8. The contractor should submit the yield report, permissions and geologist report along with final bill without which the bill shall not be accepted.
