146th MEETING HELD ONAUGUST 14TH 2020 THROUGH VIDEO CONFERENCING

BRIEF RECORD OF DISCUSSIONS

The 146th meeting of the Advisory Committee of Department of Water Resources, River Development & Ganga Rejuvenation, for consideration of techno-economic viability of major & medium irrigation, flood control and multipurpose project proposals (Advisory Committee), was held under the Chairmanship of Shri U.P. Singh, Secretary to the Government of India, DoWR, RD&GR, MoJS, on Friday, 14th August, 2020 through video conferencing. The list of participants is **annexed** herewith.

At the outset, the Chairman welcomed the participants. The Member Secretary informed that Advisor (Cost) has conveyed that in view of non-availability of connectivity, he is unable to attend the meeting. However, he has forwarded his comments based on the perusal of TAC Note and DPR forwarded to him by the Member Secretary, for the schemes to be considered in the present meeting. He further informed that the same would be shared with the Members at the time of discussions on the schemes. Thereafter, the agenda for the meeting was taken up with the permission of the Chair.

I. Confirmation of the Minutes of the 145th Meeting of the Advisory Committee:

The 145th meeting of the Advisory Committee was held on 26/05/2020, through Video Conferencing. Thereafter, the Summary Record of Discussions was circulated vide letter No. T-28053/1/2020/410-22 dated 29/05/2020.

The Member Secretary briefed that the representative from Department of Expenditure had, vide email dated 27.5.2020, informed that due to connectivity problem, the issues pertaining to Schemes from Uttar Pradesh and Himachal Pradesh could not be raised by her during the meeting. These, along with write-up on the issues raised during the meeting by her, were enclosed with the mail. Thereafter, by another mail dated 10th June, 2020, she once again forwarded the balance issues which did not find place in the minutes, and has desired that the same may be appropriately incorporated in the minutes.

Members were further informed that the points discussed by Deptt. of Expenditure representative during the meeting, were duly incorporated in the minutes. However, the other issues which were not discussed in the meeting, have not been incorporated in the minutes. Thereafter, by a short presentation, the Member Secretary briefed the participants regarding the balance issues not

included in the minutes. It was presented in detail that these balance issues flagged by Department of Expenditure representative through emails dated 10.6.2020, are duly justified by the existing guidelines, and hence do not impact the decisions taken in the meeting.

The Chairman further emphasized that the minutes are true representation of what is actually discussed in the meeting, and extraneous issues not taken up during the meeting, should not be included in the minutes. He further stressed that the cost details discussed during the Advisory Committee meeting are merely estimates, which may vary with the actual expenditure incurred during the implementation of the project. Also, acceptance by the Advisory Committee does not entitle the scheme for any central assistance. Therefore, these estimates are to be viewed in a broad perspective.

In view of the above, the minutes of the 145thAdvisory Committee meeting circulated vide letter No. T-28053/1/2020/410-22 dated 29/05/2020, were confirmed. However, the Chairman desired that the Member Secretary may provide a detailed reply to the Deptt. of Expenditure representative in this regard.

II. Follow up Discussions of the 145th Meeting:

No follow up action was proposed.

III. Project Proposals considered by the Advisory Committee

Two Flood Control Schemes, both from Manipur, were considered by the Advisory Committee in its 146th Meeting, as per details below:

(i) Critical Flood control and anti-Erosion works along rivers in Manipur Basin (Estimated Cost Rs. 460.426 crore @ 2017 Price Level, B.C. ratio: 1.29)

The scheme proposes to provide flood protection in the six districts of Manipur, covering about 25,000 ha and benefiting 2.5 lakh population. It envisages provision of retaining wall along with bore piles at urban areas, and revetment at rural areas, as protection against bund erosion. Further, river bank trimming to restore rivers sections and to maintain the capacity for flow volume at specific sections of the river, and sluice gates to control the water level which will reduce over-flooding and inundation of water on specific area, have also been proposed. The detailed scope of the work provisioned in the scheme, is tabulated below:

(ii) An Integrated Approach To Flood Management & Control On River/Streams And Drainage in Loktak Sub-Basin Of Manipur (Estimated Cost Rs. 62.1426 crore @ 2017 Price Level, B.C. ratio: 1.41)

The scheme aims at an integrated approached in the flood affected reaches of rivers flowing within Imphal-West and Bishnupur districts of Manipur. The scheme will provide flood protection to an area to the tune of 10,000 ha and benefit 55,000 population. The provisions under the scheme include construction of embankment and improvement of river bank, retaining wall, gabion and revetment protection works, river bank trimming to restore rivers sections and to maintain the capacity for flow volume at specific sections of the river, and Sluice Gates with RCC slab culvert to control the water level. The detailed scope of work is as below:

Detailed presentation on the above two schemes was made by Secretary, WRD, Govt. of Manipur, duly supported by the Chief Secretary, Manipur.

During the presentations, Advisor (WR), NITI Ayog, wished to know the reason for adopting the flood return period of 50 years, as against 100-year return period prescribed for Flood Management works in CWC Guidelines of 2018. Director FMP Dte., CWC, clarified that since major activities proposed under the scheme pertain to bank protection works, and improvement of existing embankments as against building new embankments, 50-year return period flood prescribed in IS code 14262:1995 & 8408:1994, has been followed. Advisor (WR), NITI Ayog further wanted to know whether appropriate arrangements have been thought of for disposal of muck. It was informed by Chief Secretary, Manipur that a lot of road building activities are underway in the benefitted areas, and the muck may be suitably utilized there.

Commissioner (FM), DoWR,RD&GR desired to know if there are any issues pertaining to land acquisition etc., especially for bank trimming works in urban areas. It was assured by Govt. of Manipur representatives that no such issue is involved in the present schemes.
