
The undersigned is directed to enclose herewith MoWR, RD & GR letter No.C/18018/3/2017-E.I Section, dt. 17th January, 2018 on the above mentoned subject. It is advised that all Nodal Officers of Court Cases posted in the CWC(HQ), who have been registerted on LIMBS, must review the updation of Court/CAT cases on LIMBS on regular basis, **once in a week**, themselves to avoid any mismanagement or dely in the updation of progress of court cases on LIMBS and updation report in this regard may be submit to the undersigned **on monthly basis**.

2. The following decisions, which were taken on the above said meeting may also be required to be implemented strictly:

- i) All the LIMBS users should monitor the Court Cases periodically/once in a month to review the pending cases. They must ensure logging of LIMBS by Nodal Officers daily/regularly.
- ii) All Heads of Organisations under Admn. & GW Wing should monitor the cases once in a month. There are many cases which need to be uploaded by the CWC LIMBS users.
- iii) Nodal Officers in all organisations should update the cases on LIMBS daily basis and suitable actions may be taken for compliance.
- iv) The concerned officer/Nodal Officers should attend the court cases on the date of hearing.
- v) **All cases related with Contempt should be monitored on priority.**
- vi) Updated list may also send to US(E.IV), CWC **on every month**.

Sir,

I am directed to refer to the subject mentioned above and to say that a meeting was taken by Joint Secretary (Administration) of this Ministry [JS(A)] on 10.01.2017 with all the Divisional Heads of the Admin & GW Wings for monitoring of court cases on LIMBS. Shri Rahul Ranbir Singh, Under Secretary of the CWC was also present in the aforesaid meeting.

2. During the meeting, the JS(A) had desired that all the CAT/Court cases of CWC must be entered and updated by the respective Division/wing of CWC without any delay. The JS(A) had also desired during the meeting that the monitoring of Court/CAT cases may be reviewed by the Chief Engineer(HRM), once in a month. You are requested to ensure that all the instructions of JS(A) as above may be implemented with immediate effect.

In this context, it may be noted that the monitoring of court cases pertaining to this Ministry is being done by the Deputy Secretary(E.IV) of this Ministry, who has been nominated as the Nodal Officer for LIMBS.
