I have been directed to say that the Office of the Development Commissioner, Ministry of Micro, Small & Medium Enterprises is in the process of establishing 15 new Technology Centres under the programme known as the Technology Centre Systems Programme (TCSP) and also to upgrade the existing Technology Centres. The estimated cost of the project is Rs. 2200/- crore including a World Bank loan assistance of USD 200 Mn.

The project is at an advance stage of implementation with 10 contracts having already been signed. The project is multidimensional in nature with the construction of buildings being a major component as well as an impediment in the timely implementation of the project. This constraint is basically on account of the absence of an experienced Civil Engineer to guide the construction activities.
