Terms & Conditions:

- 1. All the type of rates as required above may be quoted for all type of vehicles.
- 2. The rates should be quoted inclusive of all taxes and levies and kept valid up to 31-05-2015.
- 3. The vehicle should not be more than 5 years old and in good condition & provided with clean white cotton upholstery 7 curtains.
- 4. The vehicle should be passed by the R.T. Authority and should have valid permit, road tax, insurance, PUC and all other required documents for plying commercial vehicles.
- 5. The vehicle will ply within the states of Telangana, Andhra Pradesh, Chhattisgarh and Odisha.
- 6. The driver should possess valid driving license to drive the vehicle and should be uniformed.
- 7. The driver should be familiar with surrounding areas of Telangana, Andhra Pradesh, Chhattisgarh and Odisha.
- 8. The driver should be conversant with at least two languages i.e. Telugu, Hindi or English.

- During the tour, expenditure on account of the daily expenses of driver, maintenance of vehicle and cost of fuel will have to be borne by the vehicle provider.
