Sub: Non-receipt of APAR's/NRC's of Junior Engineers (Civil & Mechanical) of CWC cadre – alphabets "C" to "M" - reg

APAR Section has completed manual scrutiny of APAR of 2016-17 of JE (C&M) received in APAR Section. Every effort was made to remove any inconsistency with rule position as per DoPT extant instructions.

2. It has been observed that whereas certain offices have sent two APAR reports of the same individual for the same period, many others have failed to mention the unique 9 digit Employee Code. At times, signatures and names were missing of Reporting and Reviewing Officers, certain columns were also left blank like Pen Picture, correct totalling of numerical grading awarded to Officer Reported Upon (ORU) and offices where the ORU was posted were also missing from Part I (Personal Data on the Employee).

3. Based on the APAR reports received and folders opened in APAR Section, in case of employees of JE (C&M) cadre (alphabets "C" to "M") given in Annex-I where APAR/NRC is due against individual names. It may be observed in Annex-I, that out of 101 APAR folders, there exists non-receipt of APAR/NRC in 73 of them.

4. Hence, all concerned are once again requested to get the gaps filled up immediately, **preferably on or before 09.02.2018**, so that there is no difficulty at the time of holding of DPCs for promotion, MACPs, consideration of deputation cases and roll out of eHRMS for APAR for 2017-18 from April 2018 onwards.

5. No further extension of time will be given after this cut off date.

6. This issues with the approval of CE (HRM).

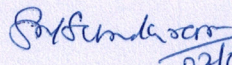

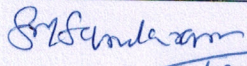
