## NOTICE INVITING QUOTATION

Sealed quotation are hereby invited by undersigned on behalf of the President of India for "Replacing A.C. Sheets of Cherribeda site Office & Painting and Distempering, under ISD, CWC, Jagdalpur from the approved and eligible contractors of CPWD/State Irrigation/PWD Departments. The quotation should reach in the Office of the undersigned on or before 07-03-2014 up to 1500 Hrs. and will be opened on the same day at 1530 Hrs.

The schedule duly filled in giving the rate and amount for each item and signed by the contractor should be enclosed along with the quotation. EMD in the form of demand draft drawn in favour of the Executive Engineer, Lower Godavari Division, CWC, on any nationalized bank payable at Hyderabad should be enclosed along with the quotation. Quotation without EMD will be rejected.

## TERMS AND CONDITIONS:

- Each bidder shall submit only one quotation. Normally, the lowest rates quoted will be accepted.
- Only those firms who are using good quality of materials as stipulated in the Indian Standards and who will be able to execute the work with in the stipulated period need to quote their rates. 2.
- The agency should have valid registration from competent government department for execution of this type of work. A copy of license to this effect & PAN number need to be enclosed with the quotation.
- All the eraser mistakes, over writings should be duly attested.
- Performance security deposit of 10 % of the quoted cost will be retained at the time of payment and the same will be released after six months or full monsoon which ever is later after checking the worthiness, trouble free performance of water proofing treatment on the existing terrace and stability at different working conditions.
- Payment will generally be made by crossed cheque / demand draft on State Bank of India within 20 days from the date of completion of full work in all respects or on receipt of the bill whichever is latter.

- 7. The material shall be accepted only after due inspection by the officer of Central Water Commission during construction and before finishing. Usage of any substandard martial if noticed will make the work liable to be rejected by CWC. Schedule of work program shall be intimated for arranging inspection.
- 8 The time allowed for carrying out the work will be 10 days from the day after the date of written order to commence the work or from the first date of handling over of the site, whichever is later
- Quotation, placed in a sealed envelope, with the Name of the work and due date written on the envelope, will be received by *The Sub Divisional Engineer, Indraveti Sub Division, CWC, Kumharpara, Jagdalpur* up to 15.00 hrs on 07-03-2014 and will be opened by him or his authorized representative in his office on the same day at 15.30 hrs.
- The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without assigning any reason. And also reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted
- All quotations in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
- 12 The quotation for the works shall remain for acceptance for a period of ninety days from the date of opening of quotation. If any tenderer withdraws his quotation, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.

## 13 Dispute settlement

If over the works, any dispute arises between the two parties, relating to any aspects of this Agreement, the parties shall first attempt to settle the dispute through mutual and amicable consultation. In the event of agreement not being reached, the matter will be referred for arbitration by a Sole Arbitrator not below the level of retired Superintending Engineer, CPWD to be appointed by the first party. The Arbitration will be conducted in accordance with the Arbitration and Conciliation Act, 1996. The decision of the Arbitrator shall be final and binding on both the parties.

## Other terms and conditions

The Engineer-in-Charge may require the contractor to remove any material which are considered by him to be a danger or inconvenience to the public or cause them to be removed at the contractor's cost
- Any damage to work resulting from rains or from any other cause until the work is taken over by 1.2 the Department after completion will be made good by the contractor at his own cost.
- The contractor shall get himself acquainted with the nature of work and satisfy himself about the 1.3 availability of material for collection and conveyance of material required for the fabrication/construction. The contractor's quoted rate should take into account all these factors and will not be allowed any extra lead for collection and conveyance of materials for any reason whatsoever.
- The contractor shall confirm to the provision of any Government Acts which relate to works and to the regulations and bye-laws of any local authorities. The contractor shall give all notices required by the said acts or laws etc., Pay all fees payable to such authorities and allow for these contingencies in his tendered rates including fees for encroachments, costs of restoration etc., and all other fees payable to the local authorities.
- The rate for all items of work shall unless clearly specified otherwise include cost of all labour, 1.5 materials and other inputs involved in the execution of item.
