'Midnight gazette' usurps TS' rights

Govt's gazette notification empowers KRMB, GRMB to take control of all major, medium projects in State; move to come into effect from October 14

STATE BUREAU HYDERABAD

Sneaking in on the Telangana State government in an unprecedented and shocking midnight exercise, the BJP government at the Centre launched initiatives to take complete control of all the major and medium irrigation projects in the State.

The Ministry of Jal Shakti (MoJS) issued a gazette notification late on Thursday night that gave complete control of scores of projects in Telangana to the Krishna River Management Board (KRMB) and the Godavari River Management Board (GRMB). The notification usurping all the rights of the State will come into effect from October 14.

According to the notification, the two water boards will have complete control over operations and maintenance of common reservoirs in both Krishna and Godavari basins. Subsequently, 36 projects in the Krishna basin and 71 projects in the Godavari basin will come under the control of KRMB and GRMB respectively from October 14.

states that both Telangana and Andhra Pradesh will have to stop works at 'unapproved projects' immediately and obtain approvals within six months of the notification, failing which these projects shall cease to operate. This would adversely impact several irrigation projects in Telangana including Palamuru Rangareddy Lift Irrigation Scheme, Dindi Lift Irrigation

tion Scheme and Srirama project that were expected to provide much-needed irrigation and drinking water facilities to the onceparched Telangana.

The notification also provides for posting officers from the Central government to the two boards within 30 days of the publication, which in other words, translates into the Centre having total com-

mand over the functioning of KRMB and GRMB.

What comes as a shock is that all the sanctioned posts in the projects will come under the jurisdiction of the two boards, besides plants, machinery, equipment, and stores too. The boards will also get to control office premises, equipment, furniture, vehicles, records and documents of the projects. And to top it all, the two

States will also have to deposit Rs 200 crore each with the boards towards 'operation and maintenance costs.'

The boards will also have control over matters pertaining to power generation, transmission and distribution. All the major and medium projects have been notified leaving only the minor irrigation projects to the States.

GNAWING AWAY AT STATES' POWERS

The BJP government, which started chipping away at the federal structure of the Constitution from the day it came to power, has now brazenly switched to demolition mode, as is switched to demolition mode, as is evident from the midnight notification that gives complete control of major and minor irrigation projects to the Krishna River Management Board (KRMB) and the Godavari River Management Board (GRMB). The notification, slipped in stealthily late on Thursday night, gives the two boards absolute control over all the projects on the Krishna and Go-

ily late on Thursday night, gives the two boards absolute control over all the projects on the Krishna and Godavari basins. The Centre cited the inter-State dispute between Telangana and Andhra Pradesh on river water sharing, taking shelter under Section 87 of the AP Reorganisation Act (APRA) of 2014 and the grey areas in the Constitution on placement of water management and irrigation in the Concurrent list.

Applying the same yardstick, the BJP government can be questioned on how it cleared the pre-feasibility report of the Mekedatu project on River Cauvery in Karmataka, where the saffron party is in power, despite the decades-long stand-off between Karnataka and Tamil Nadu on Cauvery water sharing.

Awasthi, addressing the media in New Delhi on Friday, said the gazette notification was issued after "many deliberations with stakehold-ers from Telangana and Andhra Pradesh and officials from the Central Water Commission (CWC).

Explaining the salient features of the notification, he said: "It's a super-sensitive issue. As far as the Union government is concerned, it was placed in a position where it had to placed in a position where it had to function like an empire with a lot of efforts and meetings going into building a consensus. Consensus can be on major issues or minor issues like the shifting of the headquarters of Krishna River Management Board (KRMB) to AP. We need to do it keeping in mind the sentiments and aspirations of all the stakeholders."

aspirations of all the stakeholders."
Stating that a lot of time had gone into consensus building, he said it was because of the number of internal efforts within the Ministry along with the stakeholders concerned from the first meeting of the Apex Council to the second that the government could get some sort of agreement or clarity on the way forward, he said. "Seven years seems to be a long time, but it was essential to bring all the stakeholders on board and sit together to seek mutual coand sit together to seek mutual co-operation in the interest of the two States," he said.

These provisions include the constitution of Codavari and Krishna Pivor. tution of Godavari and Krishna River tution of Godavari and Krisma River Management Boards apart from an Apex Council for supervision of the functioning of these boards. The Union government, in exer-cise of powers conferred under Sec-tion 85 of the APRA, constituted the

two river management boards effec-tive from June 2, 2014, for adminis-tration, regulation, maintenance and operation of such projects on the Godavari and Krishna rivers, as may be

davari and Krisina rivers, as may be notified by the Union government from time to time. There had been a divergence be-tween the two States on the issue of notification of the jurisdiction of the notincation of the jurisdiction of the boards by the Centre. This was addressed in the second meeting of the Apex Council in October 2020 under the chairmanship of Union Minister of Jal Shakti Gajendra Singh Shekhawat with the Chief Ministers of Talegree and AP.

EUROPE FLOODS TURN DEADLY

Toll tops 120 as cities and towns across western Germany and Belgium worst hit; search on for hundreds still unaccounted for

BERLIN

At least 120 people have died in devastating floods across parts of western Germany and Belgium, officials said Friday, as rescue operations and the search for hundreds still unaccounted for continued.

German President Frank-Walter Steinmeier said he was "stunned" by the devas-tation caused by the flood-ing and pledged support to the families of those killed

the families of those killed and to cities and towns fac-ing significant damage. "In the hour of need, our country stands together," Steinmeier said in a state-ment Friday afternoon. "It's important that we show sol-idarity for those from whom the flood has taken every-

Authorities in the German state of Rhineland-Palatinate said 60 people had died there, including at least nine residents of an assisted liv-ing facility for people with disabilities. In neighboring North Rhine-Westphalia state officials put the death toll at 43, but warned that

the figure could rise further.
Rescuers were rushing
Friday to help people
trapped in their homes in the town of Erftstadt, southwest of Cologne. Regional au-thorities said several people had died after their houses collapsed due to subsidence, and aerial pictures showed

"We managed to get 50 people out of their houses

Projects on Godavari, Krishna go to Centre

CISF to guard projects; Shocked TS may challenge it in SC

A 'midnight gazette notification' issued by the Centre late on Thursday night, taking control of all major and medium irrigation projects on the Krishna and the Godavari rivers from October 14 came as a rude shock to the Telangana state government.

The sudden development came in the wake of the row over sharing of the Krishna waters between Telangana state and Andhra Pradesh, and both states lodging a series of complaints with the Centre against each other over the Rayalaseema lift irrigation scheme and enhancement of the capacity of the Pothireddypadu project by the AP government and hydel power generation on the Krishna river projects by the Telangana government.

The Telangana govern-

ment has been demanding all along that the Centre determine its fair share in Krishna water first before bringing the projects under the control of Krishna River Management Board (KRMB).

Chief Minister K. Chandrashekar Rao on Friday held an emergency meeting at Pragathi Bhavan with officials to take stock of the situation. The Telangana government is likely to move the Supreme Court against the gazette.

He also held a meeting with TRS Lok Sabha and Rajya Sabha members on this issue. The Chief Minister asked the MPs to strongly raise their voices in the Monsoon session of Parliament set to begin from July 19 and bring pressure on the Centre to withdraw the gazette notification.

should stop all the ongoing works on unapproved projects as on the date of publication of this notification until the said projects are appraised and approved in accordance with the decisions taken in the 2nd meeting of the apex coun-

cil held last October. If approvals are not obtained within six months after the publication of this notification, full or partial operation if any of the said ongoing unapproved projects shall cease to operate.' the Centre said.

The notification also said within six months from the date of publication of the notification, both the governments should complete the unapproved projects appraised and approved.

For smooth functioning of the boards, both the Tel-

angana and AP governments shall deposit ₹200 crore each in bank accounts within 15 days of request received from the boards.

The Centre said the principles, guidelines, directions and orders issued by the boards on matters relating to power generation, transmission and distribution should be implemented by both the states.

It said if any dispute arose as to whether the KRMB had jurisdiction under sub-section (1) of section 87 of the AP Reorganisation Act, 2014, over any project, the same shall be referred to the Centre and its decision would be final.

The notification said the Central Industrial Security Force (CISF) would assist the boards in security aspects. Though both AP and Telangana governments are responsible for managing natural calamities, the boards shall advise them on management of disaster, drought or floods.

Financial liability of any contract before the commencement of the notification, liability arising out of any case filed in any court or tribunal shall be the responsibility of the respective state governments, it said.

The Centre had directed both the AP and Telangana governments to comply with its directions. It asked the boards to put in place appropriate organisational structure to perform functions within 30 days and appoint officers serving with the Centre in all categories of posts.
