CORRIGENDUM

In continuation of this Commission's Office Memorandum of even number dated 29.07.2022, the last sentence of Para-I may be read as

"All retired Government (Non-Technical) officers/officials retired as Office Superintendent/Assistant/UDC and all retired Government (Technical) officers/officials retired from Scientific, Hydromet, Communication Cadre and Central Water Engineering Service Cadre are requested to submit their application in the prescribed proforma directly to the Establishment-VII Section, CWC. The application may be sent to Establishment-VII Section, CWC by 30.08.2022 positively"

Instead of

"All retired (Technical and Non-Technical) officers/officials retired as Office Superintendent/ Assistant/UDC, technical officers retired from Scientific, Hydromet and Communication cadre are requested to submit their application in the prescribed proforma to the concerned field offices of CWC and concerned Sections/Units in CWC Head Quarter. The application may be sent through concerned offices by 15.08.2022 positively".

And

Sub-Para-f) of Para-2 may be read as

"Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed"

Instead of

"The Consultant(s) will be eligible for 08 days leave in calendar year. The leave not availed during a calendar year will not be carried forward to next calendar year".

And

I/104686/2022

Sub-Para-i) of Para-2 may be read as


"The remuneration of the contractual persons, so engaged, shall be such that the remuneration plus pension drawn by him, does not exceed the last pay drawn by such a contractual person, upon superannuation as per DoE's O.M. No. 3-25/2020-E.III.A dated 09.12.2020"

Instead of

"The emoluments as Consultant would, therefore be, limited to last pay drawn minus pension (Last basic pay + DA – basic pension + DA = emoluments that could be given to retired Government Servants on their re-engagement)".

On Para-2 of the O.M. No. A-41011/1/2022-Estt.VII/387 dated 29.07.2022 under the caption "General Terms and condition" the following two points may also be read as incorporated under points j) and k):

- j. An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, retired employees engaged as consultants may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
- k. Compliance of the relevant provisions of GFRs/extant instructions issued by the Central Government, as well as the terms of the original engagement.
