## CENTRAL WATER COMMISSION UPPER GANGA BASIN ORGANISATION

The Review Meeting of Phase III telemetry works of UGBO, CWC was held on 26.11.2019 under the Chairmanship of Shri Bhopal Singh, Chief Engineer, UGBO, CWC, Lucknow in the Conference Room of UGBO, CWC, Lucknow to discuss various issues concerning UGBO, CWC. The list of participant present is enclosed as **Annexure-I**.

At the outset, Shri Bhopal Singh, Chief Engineer, UGBO, CWC, Lucknow welcomed all the participants. EE, MGD-I and EE, MGD-II briefed about the status of works under their respective divisions. CE, UGBO raised serious concerns about progress of Phase III telemetry, as the works were still incomplete even after third extension given up to 30<sup>th</sup> November 2019. Thereafter, he requested SE(C) to take up the discussions for the meeting. The following decisions were made during the meeting:

- It was informed by representative of Mechatronics that the civil works for the modelling centre have been completed and that the server was ready for installation. He, further, informed that the server would be installed by 1<sup>st</sup> of December 2019 and the modelling centre will become functional soon after.
- It was also decided that the work on installation at 10 sites (5 RF and 5 WL+RF stations) would be started immediately.
- Considering the weather condition in hilly areas, it was decided that the teams for carrying out works at sites under HGD shall be mobilised by 1st December 2019.
- Sites (Maighat and Kalagarh) where land has not yet been handed over, the issues will be looked into by the EEs and land shall be handed over to the agency at the earliest.

CE, UGBO agreed that the agency may be granted extension up to 15<sup>th</sup> January 2019 and desired that the works may be completed within the stipulated time.

The meeting ended up with vote of thanks to the Chair.
