
कोटेशन आमंत्रण पत्र

Terms and Conditions: -

1. The agency must be having at least one work experience of similar nature in the last five years.
2. The work shall be completed as per specifications and direction of Engineer-in-Charge.
3. The rates shall be quoted both in figure as well as words also.
4. The undersigned reserve the right to accept or reject any or all the quotations without assigning any reason thereof.
5. N.I.Q no. & date of opening shall be written on the top of envelope.
6. The payment shall be made through ECS/ RTGS only after satisfactory completion/installation of work of Sl. No. 02 to 05 as per Form No. 2 and the payment of work under Sl. No. 01 shall be paid after successful completion of AMC on quarterly basis.
7. Goods & Service tax or any other tax shall be mentioned clearly.
8. Goods & Service Tax amount as applicable will be reimbursed by the department only after the submission of original paid challan/ receipt in this office.
9. The rates shall remain valid till 31.12.2021.
10. Quotationer must visit the office between 11.00 am - 4.00 pm at any working day to collect the relevant details/information regarding the above said work.
11. Bidders are requested to visit this office to inspect the EPBAX System and to get the complete information of present status of EPBAX System, immediate repairs required and submit their bid accordingly.
12. Purchaser will not have borne any cost on repair of EPBAX System except AMC charges.
13. The payment shall be made on the basis of actual measurement and quantity.
14. Work of Sl. No. 02 to 05 (as per Form No. 2) should be completed within 07 days after issue of work order.
15. In case of unsatisfactory work/installation (Sl. No. 02 to 05 as per Form No. 2) penalty would be imposed as per decision of engineer-in-charge/Assistant Engineer (Comm.). Any appeal against it, can be made to Executive Engineer. Decision of Executive Engineer would be final and binding.
16. The AMC of work (under S.No.01 as per Form No. 2) is a continued process for whole year. The complaint of EPABX should be attended same day, for any complaint up to 3.00 PM, and by the next morning 11.30 AM, in other cases, by the agency/firms. In case of any delay or unsatisfactorily work, penalty of Rs. 500/day would be imposed.
17. Quotation must include completely filled form 1 and form 2. Any ambiguity or incomplete information would result in summarily rejection of the quotations.
