Background:

1. An RTI application with No. CWCND/R/T/24/00103 dated 07/05/2024 was received in the office of Director (WP&P-Co-ord.) & CPIO, WP&P wing on transfer from Deputy Director, WSE & Nodal Officer RTI Cell on 07/05/2024.
2. Through the RTI application, latest DPR and Feasibility Report of Jamrani Dam Multipurpose Project were sought whose approval for inclusion in Pradhan Mantri Krishi Sinchayee Yojana-Accelerated Irrigation Benefit Programme (PMKSY-AIBP) of Department of Water Resources, River Development and Ganga Rejuvenation was accorded by Cabinet Committee on Economic Affairs (CCEA). CPIO, WP&P Wing replied to the applicant vide letter No. I-12011/19/2023-WPP Coord.I/173944/2024 Dated 31/05/2024.
3. The applicant has preferred an appeal and questioned about why the RTI was not transferred to concerned State Govt. authorities within stipulated time.

Decision:

I got relevant records in WP&P wing examined and found that through "RTI Online" portal (<https://rtionline.gov.in>), RTI applications/first appeals can be filed by Indian Citizens for all Ministries/Departments and other Public Authorities of Central Government. RTI applications/first appeals should not be filed for other Public authorities under State Govt through the portal. Consequently, there is no option on the portal to transfer RTI applications from one CPIO of Central Government to that of a State Government. Thus, the applicant is required to file RTI application before concerned PIO of the State Govt. of Uttarakhand.

In the view of above, the RTI Appeal No. CWCND/A/E/24/00035 dated 16-06-2024 filed by Shri Shivam Goyal is disposed off.
